### **The Defence (Finance) (Guernsey) Regulations, 1945, (Revocation) Order, 1955.**

The Royal Court, in exercise of the powers conferred on it by virtue of the Supplies and Services

(Transitional Powers) (Guernsey) Order in Council, 1946, and in pursuance of Article sixty-four of the Reform (Guernsey) Law, 1948, and of all other powers thereunto enabling it, hereby orders:—

1. The Ordinance directing that certain Defence Regulations shall have effect by virtue of the Supplies and Services (Transitional Powers) Act, 1945, as extended to the Bailiwick of Guernsey, of the 16th day of February, 1946, is hereby amended as follows:—

- (a) section two is hereby revoked;
- (b) in section three for the expression “ the First and Second Schedules ” there is hereby substituted the expression “ the First Schedule ”;
- (c) the Second Schedule is hereby revoked.

2. The Ordinances and the Orders specified in the Schedule to this Order are hereby revoked.

3. Copies of this Order shall be transmitted by Her Majesty’s Greffier to the Court of Alderney and the Seneschal of Sark for registration on the respective records of those Islands.

4. This Order shall come into operation on the 12th day of February, nineteen hundred and fifty-five.
