

**The Royal Court (Costs and Fees)
(Amendment) Rules, 2006**

THE ROYAL COURT, in exercise of the powers conferred on it by section 1 of the Royal Court (Costs and Fees) (Guernsey) Law, 1969^a and all other powers enabling it in that behalf, hereby orders:-

Amendment to Rules of 2000.

1. For the Schedule to the Royal Court (Costs and Fees) Rules, 2000^b, substitute the Schedule set out in the Schedule to these Rules.

Transitional provisions.

2. These Rules have effect in relation to fees payable in respect of a proceeding or matter -

- (a) which is described in column 1 of the Schedule set out in the Schedule to these Rules, and
- (b) which occurs or begins on or after the date of commencement specified in Rule 4,

whether the action of which the proceeding or matter forms part began before, on or after that date.
