Under the provisions of the Harbour Dues, Fees and Charges (Alderney) Law, 1984, as amended, the States of Alderney have resolved that with effect from the 1<sup>st</sup> May 2011, Harbour Dues, Passenger Fees and additional Harbour Dues shall be those set out in the table below:-

The States further resolved that:-

- (a) in calculating the amount of any harbour dues, passenger fees or additional harbour dues, in any case where the aggregate amount is not a multiple of a whole penny, the amount payable shall be taken to the nearest whole penny below;
- (b) in this Resolution - 'cruise vessel' means a vessel which enters a harbour or the territorial waters solely for the purpose of enabling passengers thereon to visit the Island as part of the itinerary of a cruise or for the purpose of embarking or disembarking the passengers beginning or ending a cruise in the vessel and which does not occupy a berth; 'Harbour Office hours' means 0800 to 1800 hours on any day;
- (c) Statutory Instrument No.13 of 2009 is hereby repealed.
