
GUERNSEY STATUTORY INSTRUMENT

The Health Service(Payment of Authorised Suppliers)
(Supplemental Payment) Regulations, 1992

Made 30 June, 1992.
Laid before the States
Coming into operation 1 July, 1992.

THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by sections 14, 35 and Schedule 1 of the Health Service(Benefit) (Guernsey) Law, 1990(a), hereby orders:-

Supplemental payment to authorised suppliers

1. An authorised supplier shall be paid out of the Guernsey Health Service Fund in respect of each item of pharmaceutical benefit -

- (a) which was supplied by him under the Health Service (Pharmaceutical) (Guernsey) Law, 1972, as amended(b), or under the Health Service(Benefit) (Guernsey) Law, 1990 during the period commencing on the 1st day of March 1990 and ending on the 31st day of December 1991; and
- (b) in respect of which payment has been made out of that Fund upon the receipt by the Authority of a certificate relating to any part of that period and issued by the body appointed by the Authority to calculate the sum payable to authorised suppliers in respect of pharmaceutical benefit supplied by them under the said Laws;

in addition to that payment, a sum equal to -

- (i) 0.878 pence per item of pharmaceutical benefit so supplied during the period commencing on the 1st day of March 1990 and ending on the 31st day of May 1991, less 0.945 pence per item of pharmaceutical benefit so supplied during the period commencing on the 1st day of June 1991 and ending on the 31st day of December 1991 where the authorised supplier is a pharmacist not employed by a medical practice; or

- (ii) 4.276 pence per item of pharmaceutical benefit so supplied during the period commencing on the 1st day of March 1990 and ending on the 31st day of May 1991, less 2.065 pence per item of pharmaceutical benefit so supplied during the period 1 June 1991 to 31 December 1991 where the authorised supplier is a medical practitioner.

Extent

2. These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

Citation

3. These Regulations may be cited as the Health Service (Payment of Authorised Suppliers) (Supplemental Payment) Regulations, 1992.

Commencement

4. These Regulations shall come into operation on the 1st day of July 1992.
