THE IMPORTATION OF MEAT AND MEAT PRODUCTS (NO.3) ORDER, 2001

Made	13 March 2001
Laid before the States	2001
Coming into force	13 March 2001

The States Agriculture and Countryside Board, in pursuance of the powers conferred by Sections 10 and 11(1) of the Animals and Animal Products (Import and Export) Ordinance, 1952, as amended (a), hereby orders:

1. The importation into the Island from the United Kingdom, the Republic of Ireland, Isle of Man or Jersey of any carcase of an animal is prohibited other than under the authority of a licence issued by the Board.
2. The importation into the Island of the carcase of an animal from:
 - i) a Member State of the European Community, other than the United Kingdom or the Republic of Ireland; and
 - ii) any of the approved countries listed in Schedule 1,is permitted under the authority of a licence issued by the Board.
3. In this Order the following meanings shall apply:

“Animal” means cattle, sheep, pigs, goats, all other ruminating animals, horses, rabbits, hares, wild boar and deer.

“Carcase” means the carcase of any animal or any part thereof;

“Island” means the Islands of Guernsey, Herm and Jethou.
4. The enactments listed in Schedule 2 are hereby revoked.
5. The Interpretation (Guernsey) Law, 1948 (b) applies to the interpretation of this Order as it applies to the interpretation of an enactment.

6. This Order may be cited as the Importation of Meat and Meat Products (No.3) Order, 2001
7. This Order shall come into force on 13 March 2001.

EXPLANATORY NOTE.

This Order allows the Board to control, through a system of licensing, the importation into the Island of meat and meat products from cattle, sheep, pigs and goats, from:

- a) the United Kingdom,
- b) the Republic of Ireland,
- c) any other Member State of the European Community,
- d) the Isle of Man
- e) Jersey; and
- f) specified other countries.
