The Milk (Wholesale Prices) (Guernsey) Order, 1979.

THE STATES DAIRY COMMITTEE, in exercise of the powers conferred upon it by subsection (1) and subsection (3) of section six of the Milk (Control) (Guernsey) Ordinance, 1958, as amended, and of all other powers thereunto enabling it, hereby orders:-

1. During the period commencing on the first day of July, nineteen hundred and seventy-nine, and ending on the thirtieth day of June, nineteen hundred and eighty (hereafter in this Order referred to as "the prescribed period"), the standard price payable by the States Dairy Committee (hereafter in this Order referred to as "the Committee") in respect of Grade 1 milk delivered to the Committee under the provisions of the Milk (Control) (Guernsey) Ordinance, 1958 (hereafter in this Order referred to as "the Ordinance"), during the prescribed period which is not surplus to the Island's milk requirements shall be 21.405p per litre during the period commencing on the first day of July, nineteen hundred and seventy-nine, and ending on the thirtieth day of November, nineteen hundred and seventy-nine; 23.127p per litre during the period commencing on the first day of December, nineteen hundred and seventy-nine, and ending on the thirtieth day of June, nineteen hundred and eighty.
2. During the prescribed period the price per litre payable by the Committee in respect of milk delivered to the Committee under the provisions of the Ordinance and classified as -

(a) Grade 1 milk -

(i) where such milk is not surplus to the Island's milk requirements, shall be during each month specified in the first column of the Schedule to this Order, the price specified in relation to such month in the second column of that Schedule;

(ii) where such milk is surplus to the Island's milk requirements, shall be such reasonable commercial price as the Committee shall from time to time determine;

(b) Grade 2 milk, shall be such reasonable price as the Committee shall from time to time determine.

3. The Milk (Wholesale Prices) (Guernsey) Order, 1978 is hereby revoked.

4. The Interpretation (Guernsey) Law, 1948, shall apply to the interpretation of this Order as it applies to the interpretation of an enactment.

5. This Order may be cited as the Milk (Wholesale Prices) (Guernsey) Order, 1979, and shall come into force on the first day of July, nineteen hundred and seventy-nine.
