The Parking Places (Amendment) Order 1985

Made the twenty-eighth day of June, 1985.

Coming into operation on the fourth day of July, 1985.

THE ISLAND POLICE COMMITTEE, in exercise of the powers conferred upon it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963 as amended(a), hereby orders:-

to Order

1. The Parking Places Order, 1984(b) is hereby amended as follows:
- (a) in section 10(a) thereof, for "and D112" there is substituted "D112, D124 and D126";
 - (b) in section 10(b) thereof, for "and D117" there is substituted "D117 and D125";
 - (c) in section 10(c) thereof -
 - (i) immediately after "D100 ," there is inserted "D103,";
 - (ii) for "and D120" there is substituted ", D120, D127 and D128";
 - (d) in section 10(d) thereof, for "and D114" there is substituted ", D114 and D129";
 - (e) in section 10(e) thereof the reference to disc parking place No "D103" is deleted;

(f) in Part I of the First Schedule thereto -

(i) in the entry in the third column relating to disc parking place No D24, for "its junction with Hauteville" there is substituted "No 21, Pedvin Street";

(ii) in the entry in the third column relating to disc parking place No D69. for "Lower Vauvert" there is substituted "Les Petites Fontaines" and all of the words after "Valnord Road" are deleted;

(iii) immediately after the entries in the first, second and third columns relating to disc parking place No D123 there are respectively inserted the following additional entries:

No.	Situation	Disc Parking Places
"D124	South Esplanade, Saint Peter Port.	The extreme west side of the road to the west of the Bus Terminus between a parking sign placed as near as may be to Havelet House and a parking sign placed as near as may be to the premises known as the Harbour Lights public house, but excluding approved parking place No A53.
D125	South Esplanade, Saint Peter Port	The area immediately to the west of the Bus Terminus within the limits indicated by parking signs.
D126	Victoria Road, Saint Peter Port	The south side of the road between a parking sign placed as near as may be to its junction with Lower Vauvert and a parking sign placed as near as may be to its junction with Les Petites Fontaines, but excluding approved parking place No MB17.

No.	Situation	Disc Parking Places
D127	Paris Street, Saint Peter Port.	The west side of the road between a parking sign placed as near as may be to its junction with New Paris Road and a parking sign placed as near as may be to No 17, Paris Street.
D128	Hirzel Street and Hospital Lane, Saint Peter Port	The east side of Hirzel Street and the south side of Hospital Lane between a parking sign placed near the junction of Hirzel Street and Hospital Lane and a parking sign placed as near as may be to the junction of Hospital Lane and Sir William Place.
D129	Pedvin Street, Saint Peter Port.	The north side of the road between a parking sign placed opposite No 16, Pedvin Street and a parking sign placed as near as may be to its junction with Hauteville. "

(g) in Part II of the First Schedule thereto, immediately after the entries in the first and second columns relating to approved parking place No A24 there are respectively inserted the following additional entries:

No.	Situation
"A24A	Les Genats. "


(h) in Part III of the First Schedule thereto, immediately after the entries in the first, second and third columns relating to approved parking place No MB18 there are respectively inserted the following additional entries:

No	Situation	Approved Parking Places
"MB19	Victoria Terrace, Saint Peter Port.	The portion of the north side of the road immediately to the east of disc parking place No D26 indicated by parking signs as being reserved for motor bicycles."

Citation 2. This Order may be cited as the Parking Places
(Amendment) Order, 1985.

Commencement. 3. This Order shall come into force on the 4th day of
July, 1985.
