**THE ALDERNEY GAMBLING CONTROL COMMISSION**, in exercise of the powers conferred on it by sections 4(2), 14(3), 15(4), 20 and 25 of the Alderney eGambling Ordinance, 2006<sup>a</sup>, hereby makes the following Regulations:-

**Modification of Commission address on application forms.**

1. In the application forms set out in-

- (a) Part I of each of Schedules 1 to 6;
- (b) Part IV of Schedule 3; and
- (c) Parts II and V of Schedule 6,

of the 2006 Regulations for-

wherever it appears as part of the address of the Alderney Gambling Control Commission substitute-

“St Anne’s House,  
Queen Elizabeth II Street,  
ALDERNEY,  
GY9 3TB,”.

**Minor amendments.**

2. (1) In the “ARRANGEMENT OF REGULATIONS” of the 2006 Regulations, for the text corresponding to the entry for Part II of Schedule 6 substitute “[not in use]”.

(2) Part II of Schedule 6 to the 2006 Regulations is hereby repealed.

**Interpretation.**

3. (1) In these Regulations, “**the 2006 Regulations**” means the Alderney eGambling Regulations, 2006, as amended by the Alderney eGambling (Amendment) Regulations, 2006, the Alderney eGambling (Amendment) (No. 2) Regulations, 2006, the Alderney eGambling (Amendment) Regulations, 2007, the Alderney eGambling (Money Laundering Amendments) Regulations, 2008, the Alderney eGambling (Amendment) Regulations, 2008 and the Alderney eGambling (Amendment) (No. 2) Regulations, 2008.

(2) The Interpretation (Guernsey) Law, 1948<sup>b</sup> applies to the interpretation of these Regulations as it applies to the interpretation of an enactment in force in the Island of Guernsey.

4. These Regulations may be cited as the Alderney eGambling (Amendment) (No. 3) Regulations, 2008.

**Commencement.**

5. These Regulations shall come into force on the 6<sup>th</sup> November, 2008.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations are made by the Alderney Gambling Control Commission under the Alderney eGambling Ordinance, 2006, as amended, and modify the address to which application forms set out in the Schedules to those Regulations must be sent and remove Part II of Schedule 6, which is no longer required.

Regulation 1 substitutes the address of the Commission on each of the forms set out in the Schedules to the Regulations so that it corresponds with the offices to which the Commission moved earlier in the year, rather than being a PO Box number. Regulation 2 repeals Part II of Schedule 6, which has become inapplicable following the changes effected by the Alderney eGambling (Amendment) (No. 2) Regulations, 2008. Regulations 3, 4 and 5 contain the interpretation, citation and commencement provisions.
