## GUERNSEY STATUTORY INSTRUMENT

2004 — No 11

The Parking Places (Amendment) (No.2) Order, 2004Made----- 4<sup>th</sup> March 2004

Coming into operation on----- 15th March 2004

**THE STATES TRAFFIC COMMITTEE**, in exercise of the powers conferred upon it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended(a), hereby orders:-

1. The Parking Places Order, 1991, as amended(b) is further amended in accordance with Articles 2 to 4 of this Order.
2. In Part C of Schedule 1, immediately following the entry related to Disc Parking Place No. DC39, insert the following entries-



| DC40 | Mount Durand | The south and north sides of the road within the limits indicated by signs.  |
| DC41 | Valnord      | The north, east and north-east sides of the portion of the road between parking signs placed as near as may be opposite and to the north of the junction with Valnord Hill and the junction with Mount Durand but excluding Approved Parking Place No. AB13. |
| DC42 | Valnord      | The west side of the portion of the road immediately to the south of the junction with Les Petites Fontaines.  |
| DC43 | Valnord Hill | The north-west side of the road, but excluding Approved Parking Place No. AB12a.   |

5. This Order may be cited as the Parking Places (Amendment) (No.2) Order, 2004.
6. This Order shall come into force on 15<sup>th</sup> March, 2004.
