The Parking Places Order, 1984

Made on the eleventh day of June, 1984

Coming into force on the eighteenth day of June, 1984

THE ISLAND POLICE COMMITTEE, in exercise of the powers conferred upon it by section one of the Road Traffic (Parking Places) Ordinance, 1963, as amended (a) hereby orders:-

1. The areas and parts, set out in the third column of Part I of the First Schedule of this Order, of the public highways set out in the second column of that Schedule respectively opposite thereto are hereby designated disc parking places and are hereafter in this Order referred to by the numbers respectively assigned to them in the first column of that Part of that Schedule.

2. The areas and parts, set out in the third column of Part II, Part III and Part IV of the First Schedule to this Order, of the public highways set out in the second column of that Schedule respectively opposite thereto are hereby designated approved parking places and are hereafter in this Order referred to by the numbers respectively assigned to them in the first column of those Parts of that Schedule.

3. The areas and parts, set out in the third column of Part V of the First Schedule to this Order, of the public highways set out in the second column of that Schedule respectively opposite thereto are hereby designated reserved parking places and are hereafter in this Order referred to by the numbers respectively assigned to them in the first column of that Part of that Schedule.

4. A person, being in charge of a vehicle, shall not park that vehicle in any of the approved parking places set out in Part III of the First Schedule to this Order.

5. A person, being in charge of a motor bicycle, shall not park that motor bicycle in any of the disc parking places set out in Part I of the First Schedule to this Order.

6. A person -

(a) being in charge of a vehicle, shall not park that vehicle in disc parking places Nos D7, D8 or D53, or

(b) being in charge of a motor bicycle, shall not park that motor bicycle in approved parking place No MB4.

when those parking places are being used, or are required for use, in connection with any vessel.

7. A person, being in charge of a public vehicle, shall not park that vehicle in any disc parking place or approved parking place except when that vehicle is on hire to a passenger:

Provided that -

- (a) in the case of a public vehicle in respect of which there is in force a taxi licence, such person may park that vehicle -
 - (i) in any of the approved parking places Nos
A2, A3, A4, A45, A50, A51, A52 or A53,
for the purposes of standing or plying for hire;
 - (ii) On the west side of the area of the road comprised in approved parking place No A4 between the hours of midnight of any day and midnight of the day next following for any continuous period not greater than a period of one hour for purposes other than standing or plying for hire;
 - (iii) in any of the disc parking places specified in Part I of the First Schedule to this Order in accordance with the provisions of section ten of this Order regulating the parking of vehicles in any such disc parking place, notwithstanding that the vehicle is not on hire to a passenger;
- (b) in the case of a public vehicle in respect of which there is in force a private hire motor car licence, such person may park that vehicle in any of the disc parking places specified in Part I of the First Schedule to this Order in accordance with the provisions of section ten of this Order regulating the parking of vehicles in any such disc parking place, notwithstanding that the vehicle is not on hire to a passenger.

8. A person who carries on the business of a dealer in or repairer of vehicles, or who carries on the business of letting vehicles on hire, shall not cause or permit any vehicle in his possession in the course of any such business as aforesaid, whether as owner, bailee or otherwise, to be parked in any disc parking place, approved parking place or reserved parking place, nor shall any servant or agent of his being in charge of any such vehicle cause or permit that vehicle to be so parked.

- 9. (1) A person, being in charge of a vehicle other than an omnibus, or being in charge of a motor bicycle, shall not without the permission in writing of the Chief Officer park that vehicle or motor bicycle in approved parking place No A1.
- (2) A person, being in charge of a vehicle or a motor bicycle other than a public vehicle standing or plying for hire shall not park that vehicle or motor bicycle in approved parking places Nos
A2, A3, A4, A45, A50, A51, A52, or A53:

Provided that in the case of a public vehicle in respect of which there is in force a taxi licence, such person may park that vehicle on the west side of the area of the road comprised in approved parking place No A4 for purposes other than standing or plying for hire in accordance with the provisions of paragraph (ii) of proviso (a) to section seven of this Order.

- (3) A person, being in charge of a vehicle, shall not without the permission in writing of the Chief Officer park that vehicle in approved parking places Nos

A47, A48 or A49

between the hours of eight o'clock in the forenoon and six o'clock in the afternoon of any day except on any Sunday or Bank Holiday.

10. A person, being in charge of a vehicle, shall not, without the permission in writing of the Chief Officer, park that vehicle

- (a) in disc parking places Nos D18, D21, D22, D28, D57, D87, D92, and D112 -

(i) between the hours of eight o'clock in the forenoon and six o'clock in the afternoon of any day for any continuous period greater than a period of thirty minutes, or

(ii) between the hours of six o'clock in the afternoon of any day and eight o'clock in the forenoon of the day next following for any continuous period greater than a period of ten hours;

- (b) in disc parking places Nos

D2, D4, D7, D13, D16, D17, D39, D51, D56, D60, D61, D62, D63, D64, D66, D67, D68, D69, D70, D71, D72, D73, D74, D75, D85, D86, D89, D90, D116, and D117 -

(i) between the hours of eight o'clock in the forenoon and six o'clock in the afternoon of any day for a continuous period greater than a period of one hour, or

(ii) between the hours of six o'clock in the afternoon of any day and eight o'clock in the forenoon of the day next following for any continuous period greater than a period of ten hours;

- (c) in disc parking places Nos

D8, D10, D23, D24, D33, D34, D50, D52, D53, D65, D91, D98, D99, D100, D104, D109, D110 and D120 -

(i) between the hours of eight o'clock in the forenoon and six o'clock in the afternoon of any day for a continuous period greater than a period of two hours, or

(ii) between the hours of six o'clock in the afternoon of any day and eight o'clock in the forenoon of the day next following for any continuous period greater than a period of ten hours;

(d) in disc parking places Nos

D1, D3, D5, D6, D9, D15, D19, D25, D30, D32, D35, D36, D37, D38, D40, D41, D44, D45, D49, D55, D58, D59, D76, D77, D79, D81, D82, D83, D84, D93, D94, D95, D96, D97, D105, D113 and D114 -

(i) between the hours of eight o'clock in the forenoon and six o'clock in the afternoon of any day for a continuous period greater than a period of five hours, or

(ii) between the hours of six o'clock in the afternoon of any day and eight o'clock in the forenoon of the day next following for a continuous period greater than a period of ten hours;

(e) in disc parking places Nos

D11, D12, D14, D26, D27, D29, D31, D42, D43, D46, D47, D48, D54, D78, D80, D88, D101, D102, D103, D106, D107, D108, D115, D118, D119, D121, D122 and D123 -

between the hours of midnight of any day and midnight of the day next following for any continuous period greater than a period of ten hours;

(f) in disc parking places Nos D20 and D111 -

(i) during the hours in which the Public Markets are open for business save that -

(a) a person, being in charge of a motor delivery vehicle, may park that motor delivery vehicle in either of those disc parking places for any continuous period not greater than a period of thirty minutes between the hours beginning with the time at which the Public Markets are open for business and ending at ten o'clock in the forenoon of any day;

(b) a person, being in charge of a vehicle, may park that vehicle in either of those disc parking places for any continuous period not greater than thirty minutes between the hours beginning with the hour of ten o'clock in the forenoon and ending with the time at which the Public Markets are closed for business;

(ii) during the hours in which the Public Markets are not open for business for any continuous period greater than a period of ten hours during the said hours.

11. A person, being in charge of a vehicle or motor bicycle, shall not, without the permission in writing of the Chief Officer, park that vehicle or that motor bicycle in any of the approved parking places set out in Part II or Part III, as the case may be, of the First Schedule to this Order between the hours of midnight of any day and midnight of the day next following for any continuous period greater than a period of twenty-three hours.

12. A person, being in charge of a vehicle or a motor bicycle other than a vehicle or motor bicycle being used for police purposes, shall not, without the permission of the Chief Officer, park that vehicle or motor bicycle, as the case may be, in any of the approved parking places set out in Part IV of the First Schedule to this Order.

13. A person, being in charge of a vehicle or a motor bicycle shall not, without the permission in writing of the Chief Officer, park that vehicle or motor bicycle, as the case may be, in any of the reserved parking places set out in Part V of the First Schedule to this Order otherwise than when such vehicle or motor bicycle is being used for the purpose indicated in the third column of that Part of that Schedule in respect of that reserved parking place.

14. Notwithstanding the provisions of paragraphs (a), (b), (c), (d), and (f) of section ten of this Order, a person, being in charge of a vehicle, may park that vehicle in any of the disc parking places set out in Part I of the First Schedule to this Order, between the hours of eight o'clock in the forenoon of any Sunday or Bank Holiday, and eight o'clock in the forenoon of the day next following for any continuous period not greater than a period of ten hours.

15. A person, being in charge of a vehicle or a motor bicycle, who parks that vehicle or motor bicycle, as the case may be, in any disc parking place, approved parking place or reserved parking place, shall so park that vehicle or motor bicycle in the manner indicated by any parking sign or by white lines marked on the road by the Island Police Committee.

16. A person, being in charge of a vehicle, who parks that vehicle in a disc parking place, approved parking place or reserved parking place abreast of, and in single line with, other vehicles parked therein, that being the manner indicated in pursuance of the provisions of the last preceding section, shall park that vehicle as close as is reasonably practicable to any other vehicle parked therein or, if no other vehicle is parked therein, to that extremity of the disc parking place, approved parking place or reserved parking place, as the case may be, which is on the offside of the vehicle.

17. A person, being in charge of a vehicle, who parks that vehicle in a disc parking place, approved parking place or reserved parking place in single line and behind or in front of, any other vehicle, that being the manner indicated in pursuance of the provisions of section fifteen of this Order, shall park that vehicle as close as is reasonably practicable to the kerb or the edge of the carriageway as the case may be.

18. A person, being in charge of a vehicle or motor bicycle, which is parked in a disc parking place, approved parking place or reserved parking place shall move that vehicle, or motor bicycle as the case may be, from that disc parking place, approved parking place or reserved parking place or from any part of that disc parking place, approved parking place or reserved parking place, as the case may be, to any other part thereof on the request of any person having reasonable grounds for making such a request or at the request of an officer of police.

19. A person, being in charge of a vehicle, shall not park that vehicle in a disc parking place, approved parking place or reserved parking place and engage, or cause or permit any other person to engage, in any trade or business in or from that vehicle while so parked.

20. (1) In this Order, unless the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them, that is to say :-

"Bank Holiday" means a day appointed as a Bank Holiday by Ordinance;

"the Chief Officer" means the Chief Officer of the Island Police Force;

"motor delivery vehicle" means any vehicle which is designed or constructed for use wholly or mainly for the carriage of goods;

"officer of police" means a member of the salaried police force of the Island of Guernsey and, within the limit of his jurisdiction, a member of the special constabulary of the Island of Guernsey;

"the Ordinance of 1963" means the Road Traffic (Parking Places) Ordinance, 1963 (b);

"the Ordinance of 1983" means the Public Transport Licensing Ordinance, 1983 (c);

"parking sign" means a sign erected, placed or marked on or near a public highway by the Island Police Committee indicating the limits of a disc parking place, an approved parking place or a reserved parking place and the conditions upon which vehicles or motor bicycles may be parked therein;

"private hire motor car licence" has the meaning assigned to it by section fifty-eight of the Ordinance of 1983;

"public vehicle" means a vehicle which is used for the carriage of passengers for hire or reward and which is offered for use either by standing or plying for hire or which is so offered in any other way whatsoever;

"taxi licence" has the meaning assigned to it by section fifty-eight of the Ordinance of 1983;

and any other expressions have the same meanings as in the Ordinance of 1963.

(2) The Interpretation (Guernsey) Law, 1948 (d) shall apply to the Interpretation of this Order as it applies to the interpretation of an enactment.

(3) Any reference in this Order to any other enactment shall, except where the context otherwise requires, be construed as including a reference to that enactment as amended, repealed or replaced, extended or applied by or under any other enactment including this Order.

21. Notwithstanding the preceding provisions of this Order, the Chief Officer may in his discretion, from time to time, close any disc parking place, approved parking place or reserved parking place by exhibiting or causing to be exhibited thereon in such a manner as to be clearly visible to a person intending to park a vehicle or a motor bicycle thereon a notice stating that the disc parking place, approved parking place or reserved parking place as the case may be, is closed and is not available for the parking of vehicles or motor bicycles and may in his discretion reopen such disc parking place, approved parking place or reserved parking place by the removal of the said notice.

22. The Orders set out in the Second Schedule to this Order are hereby repealed.

23. This Order may be cited as the Parking Places Order, 1984.

24. This Order shall come into force on the ^{18th} day of June nineteen hundred and eighty-four.

No	Situation	Disc Parking Places
D1	Upper Saint James Street, Saint Peter Port	The south side of the road between New Street and the gates of the States Prison.
D2	Saint James Street, Saint Peter Port	The north side of the road between a parking sign placed at the eastern extremity of approved parking place No PV1 and a parking sign placed as near as may be to the eastern end of the road.
D3	Ann's Place and Hirzel Street, Saint Peter Port	The north side of Ann's Place and the west side of Hirzel Street between a parking sign placed to the east of the entrance to the Old Government House Hotel and a parking sign placed near the garden entrance to the Old Government House Hotel.
D4	Hirzel Street, Saint Peter Port	The east side of the road between a parking sign placed by the front wall of Hirzel House near the top of Smith Street and a parking sign placed as near as may be to the northern end of Hirzel House.
D5	Saint Julian's Avenue, Saint Peter Port	The north west side of the road between a parking sign placed at the top near the fourth tree and a parking sign placed opposite Les Canichers but excluding approved parking place No MB2.
D6	North Esplanade, Saint Peter Port	The east side of the road between a parking sign placed as near as may be to the entrance to the White Rock and a parking sign placed as near as may be to the entrance to the Victoria Pier.
D7	Victoria Pier, Saint Peter Port	The south edge of the pier between a parking sign placed at the eastern end of that side of the pier and a parking sign placed as near as may be to its junction with The Quay.
D8	Victoria Pier, Saint Peter Port	The whole pier, but excluding disc parking place No D7 and approved parking places Nos A3 and MB4.
D9	Bosq Lane, Saint Peter Port	The portion of the south side of the road within the limits indicated by parking signs.

No	Situation	Disc Parking Places
D10	The Albert Pier, Saint Peter Port	The whole pier, but excluding approved parking place No MB5.
D11	Castle Pier, Saint Peter Port	The Castle Pier from parking signs placed at its western end to parking signs placed as near as may be to the western end of the Model Yacht Pond, but excluding reserved parking place No R1.
D12	South Esplanade, Saint Peter Port	The east and west sides of the road between parking signs placed as near as may be to the Castle Pier and parking signs placed as near as may be to the Guernsey Brewery.
D13	South Esplanade, Saint Peter Port	The west side of the inner road to the west of the South Plantation between parking signs placed thereon.
D14	Les Banques, Saint Sampson	The portion of the landward side of the road situate immediately to the south of its junction with Victoria Avenue, within the limits indicated by parking signs.
D15	Cornet Street, Saint Peter Port	Both sides of the road to the south of the corner alongside Barclays Bank, between parking signs placed as near as may be to the top of the road and parking signs placed as near as may be to the Cemetery Gate.
D16	Cornet Street, Saint Peter Port	The north side of the road between a parking sign placed as near as may be to the top of the steps alongside Barclays Bank and a parking sign placed at the eastern end of the road.
D17	Truchot, Saint Peter Port	The north side of the road between a parking sign placed as near as may be to its eastern end and a parking sign placed as near as may be to Saint Julian's Court.
D18	Church Square, Saint Peter Port	Both sides of the square.
D19	New Road, Saint Sampson	The west side of the road between a parking sign placed as near as may be to a house called Ivydene and a parking sign placed as near as may be to a house called Rivermeade.
D20	Market Square, Saint Peter Port	The south side of the road.
D21	Market Street, Saint Peter Port	The south side of the road.

D22	Bordage, Saint Peter Port	The west side of the road between a parking sign placed as near as may be opposite the entrance to Tower Hill and a parking sign placed as near as may be opposite Austin House.
D23	Bordage, Saint Peter Port	The rear portion of the off street parking area at the south-western end of the road within the limits indicated by parking signs.
D24	Pedvin Street, Saint Peter Port	The north side of the road between a parking sign placed opposite No 42, Pedvin Street and a parking sign placed as near as may be to its junction with Hauteville.
D25	Park Street Square, Saint Peter Port	The whole square within the limits indicated by parking signs.
D26	Victoria Terrace, Saint Peter Port	Between a parking sign placed opposite the steps leading to Valnord and a parking sign placed as near as may be to the corner of Valnord.
D27	Valnord, Saint Peter Port	The west side between a parking sign placed as near as may be to the bottom of Petite Fontaine Lane and a parking sign placed as near as may be to the curve in the wall.
D28	Mansell Street, Saint Peter Port	The south west side of the road between parking signs placed as near as may be to each end of Holy Trinity Church.
D29	Well Road, Saint Peter Port	The north side of the road between a parking sign placed as near as may be to its junction with Paris Street and a parking sign placed as near as may be to its junction with Glategny Esplanade.
D30	Vauvert, Saint Peter Port	The west and south side of the road between a parking sign placed opposite the premises numbered 4 and a parking sign placed as near as may be to its junction with Lower Vauvert, but excluding approved parking place No MB8.
D31	Couperderie Road, Saint Peter Port	The north side of the road between a parking sign placed as near as may be to its junction with Victoria Road and a parking sign placed as near as may be to the curve in the wall.
D32	Commercial Road, Saint Sampson	The north side of the road between parking signs placed as near as may be to each end.

D33	Saint John Street, Saint Peter Port	The east side of the road between a parking sign placed as near as may be to the house numbered 15 and a parking sign placed as near as may be to the premises known as 'Melbourne House'.
D34	Union Street, Saint Peter Port	The north side of the road between a parking sign placed as near as may be to its junction with Havilland Street and a parking sign placed as near as may be to its junction with Saumarez Street.
D35	Clifton, Saint Peter Port	The west side of the road between a parking sign placed opposite Le Platon and a parking sign placed opposite Clifton Steps.
D36	Clifton, Saint Peter Port	The west side of the road between a parking sign placed opposite the Salvation Army Hall and a parking sign placed opposite Berthelot Street.
D37	North Clifton, Saint Peter Port	The north and east sides of the road between a parking sign placed as near as may be to Spurgeon Memorial Church and a parking sign placed as near as may be to its junction with Berthelot Street.
D38	New Street, Saint Peter Port	The east side of the road between a parking sign placed opposite the States Prison and a parking sign placed as near as may be to the corner of Lefebvre Street.
D39	New Street, Saint Peter Port	The west side of the road between a parking sign placed opposite Berthelot Street and a parking sign placed between premises numbered 15 and 17.
D40	Upland Road, Saint Peter Port	The east side of the road between a parking sign placed as near as may be to its junction with Grange Road and a parking sign placed as near as may be opposite to its southern junction with Monument Garden Road.
D41	Upland Road, Saint Peter Port	The west side of the road between a parking sign placed as near as may be to its junction with Monument Road and a parking sign placed as near as may be to its junction with Candie Road.
D42	Monument Road, Saint Peter Port	The south side of the road between a parking sign placed as near as may be to its junction with Upland Road and a parking sign placed as near as may be to the eastern extremity of disc parking place No D46 at its junction with Arsenal Road.

D43	Monument Garden Road, Saint Peter Port	The left hand side of the road, when travelling in a clockwise direction, between parking signs placed as near as may be to its junctions with Upland Road.

D45	Vauxlaurens, Saint Peter Port	The north side of the road between a parking sign placed as near as may be to its junction with Beauregard Lane and a parking sign placed as near as may be to the west gate of Lower Candie Gardens.
D46	Arsenal Road, Saint Peter Port	The southern side of the road between a parking sign placed as near as may be to the eastern end of the plantation and a parking sign placed as near as may be to the centre of the plantation.
D47	Route Isabelle, Saint Peter Port	The south side of the road between parking signs placed as near as may be to the New Hermitage Hotel.
D48	Les Croutes, Saint Peter Port	The west side of the road between a parking sign placed as near as may be to the entrance to Saint Stephen's Church and a parking sign placed as near as may be to its junction with St Stephen's Lane.
D49	Gategny Esplanade, Saint Peter Port	The eastern side of the road between a parking sign placed as near as may be opposite Bosq Lane and a parking sign placed opposite the entrance to Well Road, but excluding approved parking place No MB10.
D50	Gategny Esplanade, Saint Peter Port	The west side of the road between a parking sign placed near the entrance to Saint Julian's Avenue and a parking sign placed near the entrance to Well Road.
D51	Saint George's Esplanade, Saint Peter Port	The landward side of the road between a parking sign placed as near as may be to the premises known as the Foresters Arms and a parking sign placed as near as may be to its junction with Bouillon Lane.
D52	South Quay, Saint Sampson	The north side of the road between a parking sign placed on the kerb opposite New road and a parking sign placed as near as may be to the Harbour Master's Office.

D53	North Quay, Vale	The south side of the road between a parking sign placed as near as may be to its junction with Bridge Road and a parking sign placed as near as may be opposite to its junction with Hougue Jehannet Road.
D54	Route des Coutures, Vale	The east side of the road between parking signs placed on the kerb.
D55	Avenue Germaine and Ruelle Braye, Saint Peter Port	The southern side of a parking sign placed in the area between the two roads at their junction with Ville au Roi.
D56	Avenue Germaine and Ruelle Braye, Saint Peter Port	The northern side of a parking sign placed in the area between the two roads at their junction with Ville au Roi.
D57	Saint George's Esplanade, Saint Peter Port	The landward side of the road between a parking sign placed as near as may be to the premises known as No 47, Saint George's Esplanade and a parking sign placed as near as may be to the junction of the Bouet and the Longstore.
D58	The Pier to the east of the Careening Hard, Saint Peter Port	The Pier east of the Careening Hard as indicated by a parking sign placed as near as may be to its junction with Victoria Pier.
D59	Saumarez Street, Saint Peter Port	The east side of the road between parking signs.
D60	Bridge Road, Saint Sampson	The west side of the road between a parking sign placed as near as may be to its junction with Nocq Road and a parking sign placed as near as may be to its junction with Commercial Road.
D61	Bridge Road, Vale	The west side of the road between a parking sign placed as near as may be to its junction with Bridge Avenue and a parking sign placed as near as may be to its junction with La Hougue du Valle Road.
D62	The unnamed road to the north and east of the plantation at North Quay, Vale	The south and the east sides of the road between a parking sign placed as near as may be to its junction with Bridge Road and a parking sign placed as near as may be to its junction with North Quay.
