The Parking Places (Amendment) (No2) Order, 1998

Made on the 8th June 1998

Coming into force on the 14th June 1998

THE STATES TRAFFIC COMMITTEE, in exercise of the powers conferred upon it by Section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended ^(a) hereby orders: -

1. The Parking Places Order, 1991, as amended ^(b) is further amended in accordance with Articles 2 to 10 inclusive of this Order.

2. In Article 9, following paragraph (h), the following paragraph is inserted

“(i) in any Disc Parking Place in Part I of Schedule 1 –

(i) between 07.00 and 09.00 on any day other than a Saturday, Sunday or Bank Holiday except for the purpose of delivering to or collecting from trade premises for trade purposes; or

(ii) for a continuous period greater than 30 minutes ending between 09.00 and 18.00.”

3. In Part A of Schedule 1, in the third column of the entry relating to Parking Place No. DA5, at the end of the column delete”.” and insert: “but excluding Parking Place No. DI1.”

4. In Part C of Schedule 1, in the third column of the entry relating to Parking Place No. DC2, the words “1st May to 30th September inclusive” are deleted, and the words “1st June to 14th September inclusive” are substituted.

5. In Part C of Schedule 1, the third column of the entry relating to Parking Place No. DC3 is deleted.”

6. In Part E of Schedule 1, in the third column of the entry relating to Parking Place No. DE1, the words “1st October to 30th April” are deleted, and the words “15th September to 31st May are substituted.”

7. In Part E of Schedule 1, in the third column of the entry relating to Parking Place No. DE3, the words "from 15th September to 31st May inclusive" are deleted.

8. Immediately after Part H of Schedule 1, the following entry is inserted

"PART I

Disc Parking Places to which section 9 (i)
Of this Order applies


