**The States Housing (Rent and Rebate Scheme) (Guernsey)  
(Amendment) Regulations, 2006**

**THE HOUSING DEPARTMENT**, in exercise of the powers conferred on it by section 3(1) of the States Housing (Tenancies, Rent and Rebate Scheme) (Guernsey) Law, 2004<sup>1</sup> and all other powers enabling it in that behalf, hereby makes the following regulations:-

**Amendment to Regulations of 2005.**

1. The States Housing (Rent and Rebate Scheme) (Guernsey) Regulations, 2005<sup>2</sup> are amended as follows -

- (a) in the States Rental Formula appearing in the First Schedule to the Regulations of 2005, for "102%" substitute "103.85%",
- (b) in the proviso to the States Rental Formula -

- (i) in paragraph (a), for "6 May" substitute "5 May",
  - (ii) in paragraph (b), for "7 May" and "6 May" substitute "6 May" and "4 May" respectively, and
  - (iii) in paragraph (c), for "7 May" substitute "5 May",
- (c) in paragraph 7 of the appendix to the Third Schedule to the Regulations of 2005 -
- (i) in subparagraphs (a) and (b), for "£120" substitute "£130",
  - (ii) in subparagraphs (b) and (c), for "£130" substitute "£140",
  - (iii) in subparagraph (c) for "0.07%" substitute "0.065%", and
  - (iv) in subparagraphs (c) and (d) for "£263" substitute "£287",
- (d) in paragraph 8 of the appendix to the Third Schedule to the Regulations of 2005 -

- (i) in subparagraphs (a) and (b), for "£200" substitute "£220",
  - (ii) in subparagraph (b), for "0.04%" substitute "0.041%",
  - (iii) in subparagraphs (b) and (c), for "£400" substitute "£415",
  - (iv) in subparagraph (c) for "0.06%" substitute "0.054%", and
  - (v) in subparagraphs (c) and (d) for "£450" substitute "£470", and
- (e) in paragraphs 9(a) and (b) of the appendix to the Third Schedule to the Regulations of 2005, for "£5" substitute "£5.25".

**Interpretation.**

2. (1) In these Regulations, unless the context requires otherwise -
- (a) "**the Regulations of 2005**" means the States Housing (Rent and Rebate Scheme) (Guernsey) Regulations, 2005, and
  - (b) other expressions have the same meanings as in the Regulations of 2005.

These Regulations amend the States Housing (Rent and Rebate Scheme) (Guernsey) Regulations, 2005 by making changes to certain elements of the States Rental Formula, the relevant tariffs and dependent child allowances.
