

GUERNSEY STATUTORY INSTRUMENT

The Parking Places (Amendment) Order, 1992

Made on the 2nd September, 1992
Coming into force on the 7th September, 1992

THE STATES TRAFFIC COMMITTEE, in exercise of the powers conferred upon it by Section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended (a), hereby orders:-

1. The Parking Places Order, 1991, as amended (b), is amended further in accordance with Articles 2 to 7 inclusive of this Order.

2. In Part A of Schedule 1 in the third column of the entry relating to disc parking place No. DA5 delete the words and substitute the following:

"The south-east and north-west sides of the road between the junctions with Le Petit Carrefour and Market Square within the limits indicated by signs."

3. In Part B of Schedule 1, in the third column of the entry relating to disc parking place No. DB24 insert at the end of the words ", but excluding Approved Parking Place No. AC9";

4. In Part C of Schedule 1, immediately after the entry relating to disc parking place DC17 there is inserted the following additional entry:

No.	Situation	Disc Parking Place
"DC17a	Le Truchot	The south side of the portion of the road between the junctions with Doyle Street and Sir William Place."

5. In Part E of Schedule 1 -

(a) in the third column of the entry relating to disc parking place No. DE10 delete the words and substitute the following "The north side of the road within the limits indicated by signs.";

(b) in the third column of the entry relating to disc parking place No. DE11 after the words insert ", but excluding disc parking place No. DA9a".

6. In Part A of Schedule 2, immediately after the entry relating to approved parking place No. AA32 there is inserted the following additional entry:

No.	Situation	Approved Parking Place
"AA32a	Route des Coutures, Vale	The portion of the east side of the road within the limits indicated by signs.


7. In Part C of Schedule 2, immediately after the entry relating to approved parking place No. AC8 there is inserted the following additional entry:

No.	Situation	Approved Parking Place
"AC9	The Bridge, Vale	The portion of the road immediately adjacent to the junction with Bridge Avenue, indicated by signs as being reserved for persons in possession of a disabled person's badge.

8. This Order may be cited as The Parking Places (Amendment) No.2 Order, 1992.

9. This Order shall come into force on the 7th day of September, 1992.

NOTE

This explanatory note forms no part of the Amendment Order. The purpose of this Amendment Order is:

(a) To relocate the parking at the western end of Market Street in accordance with the notice published by the States Traffic Committee in La Gazette Officielle on August 1992.

(b) To introduce two-hour disc parking in the one-way section of Le Truchot.

(c) To introduce a single parking place at The Bridge for holders of disabled person's badges with the loss of one one-hour disc parking place.

(d) To increase the capacity of the motor cycle park at the Albert Pier with the loss of one two-hour parking space in accordance with the said notice. The wording of the legislation remains unchanged.

(e) To remove the parking from the section of the Castle Pier adjacent to the Fishermen's Vivier until 30th September, 1992, in accordance with the said notice. The wording of the legislation remains unchanged.

(f) To introduce 23-hour approved parking at Route des Coutures, Vale.
