THE STATES POST OFFICE BOARD, in pursuance of the powers conferred upon it by sections, 13, 14, 15, 16, 18, 20, 23, 28 and 68 of the Post Office (Guernsey) Law, 1969, as amended (a), hereby orders:-

1. The Post Office (Inland Post) Order, 1983, (b), is hereby amended as follows:-

Amendments to  
Inland Post  
Order of 1983.

- (a) in Section 16 (3) (a) (v) thereof, for the words "fifty new pence" there is substituted "65p";
- (b) in Section 44 (1) thereof, for the words "seventeen pounds" there is substituted "£18";
- (c) in the Second Schedule thereto, for the words and figures in paragraph 2 there is substituted "Recorded delivery 22p";
- (d) the First, Third and Fourth Schedules thereto are repealed and the Schedules set out in the First, Second and Third Schedules to this Order are respectively substituted therefor;
- (e) Part I of the Fifth Schedule thereto is repealed and the Part set out in the Fourth Schedule to this Order is substituted therefor.

Citation.

2. This Order may be cited as the Post Office (Inland Post) (Amendment) Order, 1984.

Commencement.

3. This Order shall come into force on the 3rd day of September, 1984.



In respect of the Post Office (Inland Post) Order, 1983, (b), the Amendment Order, 1984 makes the following alterations:

- (i) The Inland Parcel Post service has been extended to allow parcels up to 25 kg. to be transmitted in the inland post to the United Kingdom, Isle of Man and also in the local post.
- (ii) The dimensions for items acceptable for the parcel post service have been increased.
- (iii) Fees for compensation and express services in the inland post have been increased.
