The Parking Places (Amendment) Order, 2007

Made 1st June 2007

Coming into operation on 17th June 2007

THE ENVIRONMENT DEPARTMENT in exercise of the powers conferred upon it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended⁽¹⁾, hereby orders:-

1. The Parking Places Order, 1991, as amended⁽²⁾ is further amended in accordance with Articles 2 to 7 of this Order.
2. In Part A of Schedule 2, in the third column relating to Approved Parking Place No. AA23, the words “, but excluding Approved Parking Place No. AC42” are inserted following the words “St Clement’s Road”.
3. In Part A of Schedule 2, in the third column relating to Approved Parking Place No. AA43, for the words “and AC5f” substitute “, AC5f and AC41”.
4. In Part A of Schedule 2, in the third column relating to Approved Parking Place No. AA46, for the words “Place No. AC37” substitute “Places Nos. AB35 and AC37”.
5. In Part A of Schedule 2, immediately following the entry relating to Approved Parking Place No. AA86 insert the following entry:-

“AA87	Rue des Landes, Forest	The lay-by on the south side of the road adjacent to Mont Marche Estate, within the limits as indicated by signs”

6. In Part B of Schedule 2, immediately following the entry relating to Approved Parking Place No. AB34 insert the following entry:-

“AB35	Millbrook Estate	The portion of the east side of the road within the limits as indicated by signs”

7. In Part C of Schedule 2, immediately following the entry relating to Approved Parking Place No. AC40 insert the following entry:-

"AC41	Clairval Estate	The portion of the east side of the road as near as may be to No. 2 Les Maisonettes indicated by signs as being reserved for persons in possession of a disabled person's badge.
AC42	Les Amballes	The portion of the road as near as practical to No. 1 Kingston Terrace indicated by signs as being reserved for persons in possession of a disabled person's badge."

8. This Order may be cited as the Parking Places (Amendment) Order, 2007.

9. This Order shall come into force on 17th June 2007.
