**The States Policy & Finance Committee** in pursuance of the powers conferred by Article 1 of the Import and Export (Control) (Alderney) Law, 1946(a) **HEREBY ORDERS:—**

1. In the Import and Export of Goods (Control) (Alderney) Order 1995(b) as amended, after section 5, insert sections 5A and 5B as follows:-

“5A. The importation into Alderney of the carcass of an animal from:-

- (i) a Member State of the European Community other than the United Kingdom and Republic of Ireland, and
- (ii) any other country included in the list of approved countries set out in the Schedule to this Order

are prohibited other than under the authority of a licence issued by the Policy & Finance Committee under the provisions of section 2.

5B. The importation into Alderney of the carcass of an animal from any country not being a Member State of the European Union or excluded from the list of approved countries is prohibited”

2. In this Order, the following meanings shall apply:-

“**animal**” means: cattle, sheep, pigs, goats and all other ruminating animals, horses, rabbits, hares, wild boar and deer

“**carcass**” means: the carcass of any animal or any part thereof including any products made or processed from such carcass

3. The Interpretation (Guernsey) Law, 1948(c) applies to the Interpretation of the Order as it applies to the interpretation of an enactment.
4. This Order may be cited as The Import and Export (Control) (Alderney) (Amendment No 2) Order, 2001.
5. This Order shall come into force on the 15 March, 2001.
