The Post Office (Overseas Letter Post) (Amendment) Order, 1984

THE STATES POST OFFICE BOARD, in pursuance of the powers conferred upon it by sections 13, 16 and 68 of the Post Office (Guernsey) Law, 1969, as amended (a), hereby orders:-

Amendments to
Overseas Letter
Post Order of
1983.

1. The Post Office (Overseas Letter Post) Order, 1983, (b), is hereby amended as follows:-

- (a) in Section 23 thereof, for the words "one pound and twenty five new pence" there is substituted "£1.50";
- (b) in Section 25(2)(c) thereof, for the words "one pound" there is substituted "£1.10";
- (c) in Sections 26(a), 26(b), 30(a) and 30(b) thereof, for the words "twelve pounds", in each place where those words appear, there is substituted "£13";
- (d) the First, Second, Third, Sixth and Seventh Schedules thereto are repealed and the Schedules set out in the First, Second, Third, Fourth and Fifth Schedules to this Order are respectively substituted therefor.

In respect of the Post Office (Overseas Letter Post) Order, 1983, (b), the Amendment Order, 1984 attached, makes the following alterations:

- (i) The overseas letter, newspaper and small packet rates have been increased.

- (ii) The compensation fees and the postal packets in bond fees have been increased.

Citation. 2. This Order may be cited as the Post Office (Overseas Letter Post) (Amendment) Order, 1984.

Commencement. 3. This Order shall come into force on the 3rd day of September, 1984.
