2. The Post Office (Overseas Parcel Post) (Amendment) Order, 1998 (c) is repealed.


Citation.

## EXPLANATORY NOTE

This Order amends the Post Office (Overseas Parcel Post) Order, 1993:

- (i) by increasing the postage rates for overseas parcels.
- (ii) by amending the structure of the pricing zones.
