The Social Insurance (Classification)(Amendment)  
(Guernsey) Regulations, 1985

THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by section 1 of the Social Insurance (Guernsey) Law, 1978, as amended<sup>(a)</sup>, hereby orders:-

Amendment of paragraph 8 of the First Schedule to the principal Regulations

1. In paragraph 8 in column (A) of Part III of the First Schedule to the Social Insurance (Classification) (Guernsey) Regulations, 1978, as amended<sup>(b)</sup>, the words "sixteen pounds" in sub-paragraph (a) thereof are hereby repealed and the words "seventeen pounds" are hereby substituted therefor and the words "sixty-nine pounds and thirty-three pence" in sub-paragraph (b) thereof are hereby repealed and the words "seventy-three pounds and sixty-seven pence" are hereby substituted therefor.

Repeal

2. The Social Insurance (Classification) (Amendment) (Guernsey) Regulations, 1984<sup>(c)</sup> are hereby repealed.

Extent

3. These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

Citation

4. These Regulations may be cited as the Social Insurance (Classification) (Amendment) (Guernsey) Regulations, 1985.

Collective Title

5. These Regulations and the Social Insurance (Classification) (Guernsey) Regulations, 1978 to 1979, may be cited together as the Social Insurance (Classification) (Guernsey) Regulations, 1978 to 1985.

Commencement

6. These Regulations shall come into force on the 1st day of January, 1986.

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations further amend the Social Insurance (Classification) (Guernsey) Regulations, 1978, so as to provide that an insured person who is employed under a contract of service from which he derives weekly earnings of less than seventeen pounds or monthly earnings of less than seventy-three pounds and sixty-seven pence shall be treated as a non-employed person.
