THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by section 20 of the Social Insurance (Guernsey) Law, 1978, as amended^(a), hereby orders:-

Amendment of the Seventh Schedule to the principal Regulations

1. The Seventh Schedule to the Social Insurance (Contributions) (Guernsey) Regulations, 1978, as amended^(b), is hereby repealed and the Schedule set out in the Schedule to these Regulations is hereby substituted therefor.

Repeal

2. The Social Insurance (Contributions) (Amendment) (Guernsey) Regulations, 1984^(c), are hereby repealed.

Extent

3. These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

6. These Regulations shall come into force on the 1st day of January, 1986.
