

THE BOARD OF ADMINISTRATION, in exercise of its powers under Section 3 of the Import and Export of Goods (Control)(Guernsey) Order 1978 (a) hereby further modifies the Open General Import Licence granted by the said Board upon the 27th March 1984 (b), as follows:-

1. Article 1 (a) shall be amended as follows:-

- (1) In the definition of "ACP Area", "Angola," shall be inserted before "Antigua and Barbuda," , "Burkina Faso," shall be inserted after "Botswana," , "Mozambique," shall be inserted after "Mauritius," and "Upper Volta," shall be deleted.
- (2) In the definition of "OCT Area", "Greenland," shall be inserted after "French Southern and Antarctic Territories,".
- (3) In the definition of "Residual Textile Area", "the Dominican Republic," shall be inserted after "Colombia," and "Panama," shall be inserted after "Pakistan,".

2. In Article 5, paragraph (1) shall be deleted and paragraphs (2) and (3) shall be re-numbered paragraphs (1) and (2) respectively.

3. Schedule 1 shall be amended as follows:-

- (1) In Entry No. 25, "*" shall be deleted after "the Republic of Korea" in the fourth column.
- (2) In Entry No. 32, "*" shall be deleted after "Colombia", "Malaysia", "Poland" and "Thailand" and inserted after "Indonesia" in the fourth column.
- (3) In Entry No. 34, "*" shall be deleted after "German Democratic Republic and Berlin (East)" and "Taiwan" in the fourth column.
- (4) In Entry No. 36, "*" shall be deleted after "Colombia", "Hungary", "Malaysia" and "Thailand" and inserted after "Indonesia" in the fourth column.
- (5) In Entry No. 44, "ST" shall be replaced by "Albania: Bulgaria: Cambodia: China*: Czechoslovakia: German Democratic Republic and Berlin (East): Korea (North): Laos: Mongolia: Poland: the Soviet Union: Vietnam" in the fourth column and "Hungary: Romania" shall be deleted from the fifth column.
- (6) In Entry Nos. 55, 85 and 133, "*" shall be deleted after "Czechoslovakia" in the fourth column.

- (7) In Entry No. 69, "*" shall be deleted after "China". "the Republic of Korea", "Philippines" and "Taiwan" in the fourth column.
- (8) In Entry No. 72, "*" shall be deleted after "Poland" in the fourth column.
- (9) In Entry Nos. 74, 84, 98 and 109, "*" shall be deleted after "Turkey" in the fourth column.
- (10) In Entry No. 76, "*" shall be deleted after "Romania" in the fourth column.
- (11) In Entry No. 78, "*" shall be deleted after "Hong Kong" and "the Republic of Korea", and "Turkey" shall be inserted in the fourth column.
- (12) In Entry No. 80, "*" shall be inserted after "Macao" in the fourth column.
- (13) In Entry Nos. 88, 91 and 95, "*" shall be inserted after "Taiwan" in the fourth column.
- (14) In Entry Nos. 89 and 114, "*" shall be deleted after "Macao" and "Singapore" and "ST" shall be replaced by "Albania: Cambodia: China*: German Democratic Republic and Berlin (East): Korea (North): Laos: Mongolia: the Soviet Union: Vietnam" in the fourth column and "Bulgaria: Czechoslovakia: Hungary: Poland: Romania" shall be deleted from the fifth column.
- (15) In Entry Nos. 90 and 115, "*" shall be deleted after the "Republic of Korea" and "Thailand" and inserted after "China" in the fourth column, and "Turkey" shall be inserted in the fourth column.
- (16) In Entry Nos. 99 and 111, "*" shall be deleted after "Bulgaria" in the fourth column.
- (17) In Entry No. 100, "*" shall be deleted after "Bulgaria" and "Czechoslovakia" and inserted after "Taiwan" in the fourth column.
- (18) In Entry No. 101, "*" shall be inserted after "Hungary" in the fourth column.
- (19) In Entry No. 113, "*" shall be inserted after "Bulgaria" in the fourth column.
- (20) In Entry No. 124, "*" shall be deleted after "the Republic of Korea" in the fourth column.
- (21) In Entry No. 141, "*" shall be inserted after "the Republic of Korea" in the fourth column.
- (22) In Entry Nos. 85, 123 and 148, "Turkey" shall be inserted in the fourth column.

4. Schedule 2 shall be amended as follows:

(1) The following Entries shall be inserted:

1008	ex 53.05	Sheep's or lambs' wool or fine animal hair, carded or combed.	46 Argentina
1009	53.11	Woven fabrics of sheep's or lambs' wool or of fine animal hair.	50 Argentina

(2) In Entry No. 1021, "Argentina" shall be inserted in the fourth column.


(3) In Entry Nos. 1069, 1074, 1078, 1095, 1100 and 1111, "Turkey" shall be deleted from the fourth column.

(4) In Entry Nos. 1121A, 1123A, 1125, 1125B, 1126A, 1127A, 1128A, 1129A, 1131 and 1132, "Brazil" shall be inserted in the fourth column.

(5) In Entry Nos. 1125A, 1128, 1129 and 1130, "those in the Community Area and other than Spain." shall be deleted from the fourth column and "Brazil, Spain and those in the Community Area." shall be inserted in its place.

5. This amendment shall come into operation on the twenty fifth day of June, nineteen hundred and eighty-six.
