THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by section 20 of the Social Insurance (Guernsey) Law, 1978, as amended<sup>(a)</sup>, hereby orders:-

Amendment of the Seventh Schedule to the principal Regulations

1. The Seventh Schedule to the Social Insurance (Contributions) (Guernsey) Regulations, 1978, as amended<sup>(b)</sup>, is hereby repealed and the Schedule set out in the Schedule to these Regulations is hereby substituted therefor.

Repeal

2. The Social Insurance (Contributions) (Amendment) (No.2) (Guernsey) Regulations, 1983<sup>(c)</sup>, are hereby repealed.

Extent

3. These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

4. These Regulations may be cited as the Social Insurance (Contributions) (Amendment) (Guernsey) Regulations, 1984.


Collective title

5. These Regulations, the Social Insurance (Contributions) (Amendment) (Guernsey) Regulations, 1983 and the Social Insurance (Contributions) (Guernsey) Regulations, 1978 to 1982, may be cited together as the Social Insurance (Contributions) (Guernsey) Regulations, 1978 to 1984.

6. These Regulations shall come into force on the 1st day of January, 1985.

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport)

These Regulations specify the lower weekly earnings limit and the lower monthly earnings limit as respects the contribution year commencing on 1 January, 1985.
