THE STATES POST OFFICE BOARD, in pursuance of the powers conferred upon it by sections thirteen, fourteen, fifteen, sixteen, eighteen, nineteen, twenty, twenty-eight and sixty-eight of the Post Office (Guernsey) Law, 1969, as amended (a), hereby orders:-

Order.

1. The Post Office (Overseas Letter Post) Order, 1973, as amended (b), is hereby further amended as follows:-

- (a) in paragraph (c) of subsection (1) of section six thereof the figures and letter "6.5p" are repealed and the words "seven new pence" are substituted therefor;
- (b) in sub-paragraph (i) of paragraph (a) of subsection (2) of section eight thereof the word "boxes" is repealed and the word "letters" is substituted therefor;
- (c) in subsection (3) of section twelve thereof the words "twenty-seven new pence" are repealed and the words "forty new pence" are substituted therefor;
- (d) in the proviso to section twenty-six thereof the words "twenty new pence" and "two new pence" are repealed and the words "thirty new pence" and "four new pence" are respectively substituted therefor;
- (e) in paragraph (c) of subsection (2) of section twenty-seven thereof the words "forty-five new pence" are repealed and the words "sixty new pence" are substituted therefor;
- (f) in paragraphs (a) and (b) of section twenty-eight thereof the words "seven pounds" are repealed and the words "nine pounds" are substituted therefor;

- (g) in paragraph (d) of subsection (1) of section thirty thereof the words "five hundred pounds" are repealed and the words "six hundred pounds" are substituted therefor;
- (h) in paragraph (b) of the proviso to subsection (1) of section thirty-one thereof the words "five hundred pounds" are repealed and the words "six hundred pounds" are substituted therefor;
- (i) in section thirty-four thereof -
 - (i) in subsection (1) the words "ten new pence" are repealed and the figures and letter "12.5p" are substituted therefor;
 - (ii) in subsection (2) the words "twenty new pence" are repealed and the words "twenty-five new pence" are substituted therefor;
- (j) the First, Second, Third, Sixth and Seventh Schedules thereto are repealed and the Schedules set out in the First, Second, Third, Fourth and Fifth Schedules to this Order are respectively substituted therefor.

2. The Post Office (Overseas Parcel Post) Order, 1973, as amended (c), is hereby further amended as follows:-

- (a) in section five thereof the words "twenty-seven new pence" are repealed and the words "forty new pence" are substituted therefor;
- (b) in subsection (1) of section sixteen thereof -
 - (i) immediately after paragraph (a) there is inserted the following additional paragraph lettered "(b)" -
 - "(b) the sender shall also pay to the Board at the time that any amount is paid in accordance with the undertaking referred to in paragraph (a) of this subsection or repaid by the Board in accordance with paragraph (e) of this subsection a fee of twenty-five new pence for each parcel posted;"

(ii) paragraphs (b), (c) and (d) are relettered

"(c)", "(d)" and "(e)" respectively;

(c) in paragraph (e) of subsection (1) of section seventeen thereof the words "five hundred pounds" are repealed and the words "six hundred pounds" are substituted therefor;

(d) in paragraph (c) of the proviso to subsection (1) of section eighteen thereof the words "five hundred pounds" are repealed and the words "six hundred pounds" are substituted therefor;

(e) in section twenty thereof -

(i) in subsection (1) the words "ten new pence" are repealed and the figures and letter "12.5p" are substituted therefor;

(ii) in subsection (2) the words "twenty new pence" are repealed and the words "twenty-five new pence" are substituted therefor;

(f) paragraph (a) of subsection (5) of section twenty-one thereof is repealed and the following paragraph is substituted therefor -

"(a) where a parcel or parcels are stored for a period not exceeding twenty-eight days, the fee shall be one pound and forty new pence for each parcel, except where two or more parcels are posted simultaneously by a sender to the same addressee, when the fee shall be:-

(i) where there are not more than five parcels, one pound and ten new pence for each parcel;

(ii) where there are more than five parcels but not more than thirty, one pound and ten new pence for each of the first five parcels and then sixty-five new pence for each additional parcel;

(iii) where there are more than thirty parcels, for the first thirty parcels the fee for each as prescribed in sub-paragraph (ii) of paragraph (a) of this subsection and then forty new pence for each additional parcel;"

(g) the First, Second and Third Schedules thereto are repealed and the Schedules set out in the Sixth, Seventh and Eighth Schedules to this Order are respectively substituted therefor.

Amendments to

3. The Post Office (Inland Post) Order, 1973, as amended (d), is hereby further amended as follows:-

- (a) in subsection (2) of section seventeen thereof the words "twenty-five new pence in respect of a parcel and of twenty new pence in respect of any other postal packet" are repealed and the words "forty new pence in respect of any postal packet" are substituted therefor;
- (b) in section eighteen thereof -
- (i) in subsection (2) the table is repealed and the table set out in the Ninth Schedule to this Order is substituted therefor;
- (ii) paragraph (a) of subsection (5) is repealed and the following paragraph is substituted therefor -
- "(a) where a parcel or parcels are stored for a period not exceeding twenty-eight days, the fee shall be one pound and forty new pence for each parcel, except where two or more parcels are posted simultaneously by a sender to the same addressee, when the fee shall be:-
- (i) where there are not more than five parcels, one pound and ten new pence for each parcel;
- (ii) where there are more than five parcels but not more than thirty, one pound and ten new pence for each of the first five parcels and then sixty-five new pence for each additional parcel;
- (iii) where there are more than thirty parcels, for the first thirty parcels the fee for each as prescribed in sub-paragraph (ii) of paragraph (a) of this subsection and then forty new pence for each additional parcel;"

- (c) in paragraph (b) of subsection (3) of section twenty-three thereof the words "eight new pence" are repealed and the words "nine new pence" are substituted therefor;
- (d) in subsection (3) of section thirty-one thereof the words "eight new pence" are repealed and the words "nine new pence" are substituted therefor;
- (e) in subsections (2) and (3) of section thirty-eight thereof the words "eight new pence" where these words occur in these subsections are repealed and the words "nine new pence" are substituted therefor;
- (f) in section forty-two thereof -
- (i) in subsection (1) the words "forty new pence" are repealed and the words "fifty new pence" are substituted therefor;
- (ii) in subsection (3) the words "fifty pounds" are repealed and the words "one hundred pounds" are substituted therefor;
- (g) in subsection (2) of section forty-three thereof the words "thirty pounds" are repealed and the words "fifty pounds" are substituted therefor;
- (h) in sub-paragraph (a) of paragraph 4 of the First Schedule thereto the figures and letters "55p", "70p", "85p", "£1.00", "£1.10", "£1.20", "£1.30", "£1.40", "£1.50" and "£1.60" are repealed and the figures and letters "66p", "86p", "£1.06", "£1.16", "£1.26", "£1.36", "£1.46", "£1.51", "£1.56" and "£1.61" are respectively substituted therefor;
- (i) paragraphs 3, 4, 5, 6 and 7 of the Second Schedule thereto are repealed and the following paragraphs are respectively substituted therefor -
- "3. Duplicate certificate of posting of a registered postal packet ... 6.5p
4. Advice of delivery of, or inability to deliver, a registered postal packet:-
- (a) if requested at time of posting ... 12.5p
- (b) if requested after posting ... 25p

5. Enquiry for a missing registered postal packet ... 25p

(Note: This charge is not payable if the charge for advice of delivery of, or inability to deliver, the packet has already been paid by the sender. The Board may refund the enquiry charge if it is satisfied that the packet was lost or seriously delayed while in its custody.)

6. Advice of delivery of, or inability to deliver, a recorded delivery packet:-
- (a) if requested at time of posting ... 12.5p
- (b) if requested after posting ... 25p
7. Enquiry for a missing recorded delivery packet.. 25p

(Note: This charge is not payable if the charge for advice of delivery of, or inability to deliver, the packet has already been paid by the sender. The Board may refund the enquiry charge if it is satisfied that the packet was lost or seriously delayed while in its custody.)";

- (j) in Column one of Part I of the Fifth Schedule thereto the figures "0.45", "0.50" and "0.55" are repealed and the figures "0.60", "0.65" and "0.70" are respectively substituted therefor;
- (k) in paragraph 4 of the Seventh Schedule thereto the figures and letters "55p", "70p", "85p", "£1.00", "£1.10", "£1.20", "£1.30", "£1.40", "£1.50" and "£1.60" are repealed and the figures and letters "66p", "86p", "£1.06", "£1.16", "£1.26", "£1.36", "£1.46", "£1.51", "£1.56" and "£1.61" are respectively substituted therefor;
- (l) Part I of the Sixth Schedule thereto is repealed and the Part set out in the Tenth Schedule to this Order is substituted therefor.

of section two, sub-paragraph (i) of paragraph (e), paragraphs (f), (g) and (h), sub-paragraph (i) of paragraph (m) and paragraph (n) of section three of, and the Third, Fifth, Sixth, Eighth and Ninth Schedules to, the Post Office (Miscellaneous Amendments) (No. 2) Order, 1975 (f), paragraphs (c), (e) and (o) of section one of the Post Office (Overseas Letter Post) (Amendment) (No. 2) Order, 1975 (g), paragraphs (k), (l) and (p) of section one and paragraphs (j) and (k) of section two of, and the First, Third and Fourth Schedules to, the Post Office (Miscellaneous Amendments) (No. 3) Order, 1975 (h), paragraph (d) of section one and section two of, and the First, Second and Third Schedules to, the Post Office (Miscellaneous Amendments) Order, 1976 (i), and sections one and two of, and the First, Second, Third and Fourth Schedules to, the Post Office (Miscellaneous Amendments) (No. 2) Order, 1976 (j), are hereby repealed.

Citation. 5. This Order may be cited as the Post Office (Miscellaneous Amendments) Order, 1977.

Commencement. 6. This Order shall come into force on the thirteenth day of June, nineteen hundred and seventy-seven.
