The Fishing (Designation of Fisheries) Order, 1991

Made	15 February 1991
Laid before the States	27 February 1991
Coming into operation	27 February 1991

THE STATES SEA FISHERIES COMMITTEE, in exercise of the powers conferred upon it by Section 1 (1) of The Fishing (Licensing and Protection of Fisheries) Ordinance, 1987, hereby orders:-

1. That the areas of the seashore set out in the schedule attached to this Order be designated Licensed Fisheries in accordance with the Ordinance of 1987.
2. In this Order, the expression "the Ordinance of 1987" means the Fishing (Licensing and Protection of Fisheries) Ordinance, 1987, and any other expressions have the same meanings as in the Ordinance of 1987.
3. The Interpretation (Guernsey) Law, 1948 (b), shall apply to the interpretation of this Order as it applies to the interpretation of an enactment.
4. This Order may be cited as the Fishing (Designation of Fisheries) Order, 1991.
5. This Order shall come into force on the twenty-seventh day of February 1991.
