The Parking Places (Amendment) Order, 1988

Made on the 11th day of January, 1988.

Coming into force on the 4th day of February, 1988

THE ISLAND POLICE COMMITTEE, in exercise of the powers conferred upon it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended(a), hereby orders:-

1. The Parking Places Order, 1984 as amended(b), is hereby further amended as follows:-

(a) in section 10(a) thereof -

(i) the letter and figures "D92" are repealed;

(ii) the word, letters and figures "D124 and D126" are repealed and the word, letters and figures "D124, D126, D130 and D131" are substituted therefor;

(b) in section 10(e) thereof the letter and figures "D122" are repealed;

(c) in section 10 thereof the full stop at the end of paragraph (f) is deleted and a semi-colon is substituted therefor and immediately thereafter there is inserted the following additional paragraphs lettered "(g)" and "(h)" -

(a) Recueil d'Ordonnances Tome XIII, p.292; Tome XXI, p.525; No. XII of 1981.

(b) S.I. 1984 No. 12; S.I. 1985 No. 10; S.I. 1987 Nos. 6 and 25.

"(g) in disc parking place No. D122 save that, a person being in charge of a vehicle which has an overall width of six feet or less may park that vehicle between the hours of midnight of any day and midnight of the day next following for any continuous period not greater than a period of ten hours;

(h) in disc parking place No. D132 -

(i) between the hours of eight o'clock in the forenoon and ten o'clock in the forenoon of any Monday, Tuesday, Wednesday, Thursday, Friday and Saturday, save that a person being in charge of a motor delivery vehicle, may park that motor delivery vehicle for any continuous period not greater than a period of thirty minutes; or

(ii) between the hours of ten o'clock in the forenoon and six o'clock in the afternoon of any day for any continuous period greater than a period of thirty minutes; or

(iii) between the hours of six o'clock in the afternoon of any day and eight o'clock in the forenoon of the day next following for any continuous period greater than a period of ten hours.";

- (d) in section 14 thereof the words "(d) and (f)" are repealed and the words "(d), (f) and (h) are substituted therefor;
- (e) the entry relating to disc parking place No. D56 in the third column of Part I of the First Schedule thereto is repealed and the entry "The northern side of a parking sign placed in the area between the two roads at their junction with Ville au Roi but excluding approved parking place No. MB20." is substituted therefor;
- (f) the entry relating to disc parking place No. D94 in the third column of Part I of the First Schedule thereto is repealed and the entry "The west side of the road between a parking sign placed as near as may be to the house known as "Ivy Green" and a parking sign placed as near as may be to its junction with Les Amballes Road but excluding approved parking place No. MB21." is substituted therefor;
- (g) the entry relating to disc parking place No. D123 in the third column of Part I of the First Schedule thereto is repealed and the entry "The north side of the road between its junction with Guelles Road and its junction with Le Mont Arrivé within the limits indicated by parking signs but excluding approved parking place No. MB22." is substituted therefor;


- (h) immediately after the entries relating to disc parking place No. D129 in each of the columns of Part I of the First Schedule thereto there are inserted respectively the entries in each of the columns of the First Schedule to this Order;
- (i) immediately after the entries relating to approved parking place No. MB19 in each of the columns of Part III of the First Schedule thereto there are inserted respectively the entries in each of the columns of the Second Schedule to this Order.

2. The Parking Places (Amendment) (No. 2) Order, 1987(c), is hereby repealed.

3. This Order may be cited as the Parking Places (Amendment) Order, 1988.

4. This Order shall come into force on the 4th day of February, 1988.
