The Post Office (Inland Post) (Amendment) Order, 1979.

THE STATES POST OFFICE BOARD, in pursuance of the powers conferred upon it by sections thirteen, fourteen, fifteen, sixteen, twenty, twenty-eight and sixty-eight of the Post Office (Guernsey) Law, 1969, as amended(a), hereby orders:-

Amendments to
Inland Post Order
of 1973.

1. The Post Office (Inland Post) Order, 1973, as amended(b), is hereby further amended as follows:-

(a) paragraph (2) of section twenty-six thereof is repealed and the following paragraph is substituted therefor -

"(2) A rebate posting shall consist of a consignment of not less than five thousand letters all sent by the same sender for delivery within the Bailiwick of Guernsey, each (except where the Board otherwise allows) being identical with the others in size and shape and in the nature of its contents.";

(b) the First and Seventh Schedules thereto are repealed and the Schedules set out in the First and Second Schedules to this Order are respectively substituted therefor.
