The Post Office (Inland Post) (Amendment) Order, 1992

THE STATES POST OFFICE BOARD, in pursuance of the powers conferred upon it by sections 13, 14, 15, 16, 18, 20, 23, 28 and 68 of the Post Office (Guernsey) Law, 1969, as amended (a), hereby orders:-

Amendments to
Inland Post
Order of 1983.

1. The First, Second and Fourth Schedules of the Post Office (Inland Post) Order, 1983 as amended (b), are repealed and the Schedules set out in the First, Second and Third Schedules to this Order are substituted therefor.

Citation.

2. This Order may be cited as the Post Office (Inland Post) (Amendment) Order, 1992.

Commencement.

3. This Order shall come into force on the 1st day of April, 1992.

9. *Redirection by the States Post Office.*

Redirection of postal packets from their original address to the same addressee at another address in pursuance of the addressee's application:-

A.- Where the original address is a business address and the addressee has permanently ceased to occupy the premises to which the packets are addressed, or where the original address is not a business address:-

(Note: (i) where the original address is a private residence and postal packets addressed to several members of one family bearing the same surname are all to be redirected to one other address, the addressees are to be regarded together as constituting one addressee for the purpose of the fee payable.

10. *Diversion of Postal Packets. Delivery of postal packets addressed to the addressee's private address at his business address, or of postal packets addressed to one or more business addresses, at another business address of the same addressee or at his private address, where the fee mentioned in item 9 is not applicable:-*

For each address from which packets are diverted and for each style after the first in which the packets are addressed to each such address:-

(1) <i>For initial period of one year or less</i>	£55.00
(2) <i>For each subsequent full year</i>	£55.00
(3) <i>For a subsequent part only of a year</i>	A rateable proportion of the fee chargeable under (2).

11. *Search Fee. Search made at a delivery office at the request of the addressee or his agent to ascertain whether any postal packets for a particular address are available for delivery:-*

for each search 80p

(Note: This fee is not charged:-

- (a) if the search is for postal packets addressed to a post office to be called for in accordance with section twenty-four of this Order; or*
- (b) if the addressee is the holder of a Private Box at the post office concerned, or the holder of a Private Bag used for the collection of postal packets from that post office.)*

12. *Temporary Retention. Withholding of postal packets from delivery at the request of the addressee:-*

<i>For a period, unbroken except by a Sunday, up to one month</i>	£4.50
<i>up to two months</i>	£9.00

13. *Floor Fee.* For delivery of postal packets for a business address at a floor other than the ground floor, or (where the addressee is not in occupation of the ground floor) at a floor other than the floor occupied by the addressee which is nearest to the ground floor:-

For each extra floor to which the delivery officer has to ascend or descend to make the delivery, per annum

... .. Such fee not exceeding £22 as the Board may fix, having regard to the facilities available for ascent and descent.

14. *Separation Fee.* For separating postal packets addressed to a particular Department of the addressee from other postal packets addressed to the addressee at the same address and delivering them separately to that Department:-

For each Department to which postal packets are separately delivered (in addition to the floor fee where item 14 applies), per annum

15. *Private Roadside Letter Boxes.* Delivery into a private roadside letter box where the box need not be unlocked.

... .. No fee

16. *Private Delivery Service.* For separating postal packets addressed to the same address according to such codes, private box numbers, descriptions, words, figures, characters or marks used with the address as may have been approved for the purpose by the Board and for delivery by postman to a single point in advance of the general delivery:-

(1) *for initial period of one year or less*

... .. Such fee as the Board may fix for a minimum period of one year in the particular case;

(2) *for each subsequent full year*

... .. Such fee as the Board may fix for that year in the particular case;

(3) *for a subsequent part only of a year*

... .. A rateable proportion of the fee chargeable under (2).
