

THE BOARD OF ADMINISTRATION, in exercise of its powers under Section 3 of the Import and Export of Goods (Control)(Guernsey) Order 1978 (a) hereby further modifies the Open General Import Licence granted by the said Board upon the 16th February 1982 (b) as follows:-

1) Article 1(a) shall be amended as follows:-

- (a) In the definition of "ACP Area" after "Antigua" there shall be inserted "and Barbuda".
- (b) In the definition of "Synthetic Textile Area", "the ACT Area", shall be deleted, and "the ACP Area", shall be inserted in its place.

2) Article 5 shall be deleted and the following Article 5 shall be substituted therefor:-

"5. Nothing in this licence shall authorise the importation of any goods listed in Schedule 5 hereto or of any goods which have been exported from Argentina".

3) Schedule 1 shall be amended as follows:-

- (a) In Entry Nos. 16, 65, 110, 130 and 135, "Taiwan" shall be inserted in the fourth column.
- (b) Entry Nos. 24, 25, 49, 108, 124, 138, 143, 160, 173 and 183C shall be deleted.

- (l) In Entry No. 75, "Sri Lanka" and "Yugoslavia*" shall be deleted from the fourth column.

- (m) In Entry No. 76, "Malaysia" shall be deleted from the fourth column.
- (n) In Entry No. 77, "Pakistan" shall be deleted from the fourth column and "Romania" shall be deleted from the fifth column.
- (o) In Entry Nos. 83 and 112, "Pakistan*" shall be deleted from the fourth column.
- (p) In Entry No. 85, "Sri Lanka" shall be deleted from the fourth column.
- (q) In Entry Nos. 89, 114, 126 and 135, "Malaysia" shall be inserted in the fourth column.
- (r) In Entry No. 100, "Hong Kong*" and "Philippines" shall be deleted from the fourth column.
- (s) In Entry Nos. 102, 116, 126 and 131, "Singapore" shall be deleted from the fourth column.
- (t) In Entry No. 129, "Brazil" and "India" shall be deleted from the fourth column.
- (u) In Entry No. 135, "the Republic of Korea" shall be inserted in the fourth column, and "Bulgaria" and "Poland" shall be deleted from the fifth column.
- (v) In Entry No. 136, "Poland" shall be inserted in the fourth column.
- (w) Entry Nos. 204 and 204A shall be deleted and the following Entries shall be inserted in their place:-

5) Schedule 3 shall be amended as follows:-

(a) In Entry No. 2003, in the description of goods in the second column, "coalfish" shall be deleted and "saithe" shall be inserted in its place, and "or Gadus Virens" shall be deleted.

(b) In Entry No. 2005, in the description of goods in the second column, "Specific gravity of less than 0.94" shall be deleted and "density of less than 0.94g/cm³" shall be inserted in its place.

6) Amendment No. 2 to the Open General Import Licence of 1982 (c) is hereby revoked.

7) This amendment shall come into operation on the sixth day of July, nineteen hundred and eighty-three.
