The Parking Places (Amendment) (No. 3) Order, 1992

Made on the 16th October, 1992
Coming into force on the 18th October, 1992

THE STATES TRAFFIC COMMITTEE, in exercise of the powers conferred upon it by Section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended (a), hereby orders:-

1. The Parking Places Order, 1991, as amended (b), is amended further in accordance with Articles 2 to 4 inclusive of this Order.

2. In Part A of Schedule 1 immediately after the entry relating to disc parking place No. DA9 there is inserted the following additional entry:

No.	Situation	Disc Parking Place
"DA9a	Mount Durand	The portion of the south side of the road within the limits indicated by signs."

3. In Part C of Schedule 1 -

(a) in the third column of the entry relating to disc parking place No. DC2 delete the words and figures "31st October" and substitute the following "30th September";

(b) immediately after the entry relating to disc parking place DC17a there is inserted the following additional entry:

No.	Situation	Disc Parking Place
"DC17b	Doyle Street	The portion of the south side of the road within the limits indicated by signs."

4. In Part E of Schedule 1 -

(a) in the third column of the entry relating to disc parking place No. DE1 delete the words and figures "1st November" and substitute the following "1st October";


(b) immediately after the entry relating to disc parking place No. DE11 there is inserted the following additional entry:

No.	Situation	Disc Parking Place
"DE11a	Charroterie	The portion of the south-east side of the road within the limits indicated by signs."

4. This Order may be cited as The Parking Places (Amendment) No.3 Order, 1992.

5. This Order shall come into force on the 18th October, 1992.

NOTE

This explanatory note forms no part of the Amendment Order. The purpose of this Amendment Order is:

(a) To implement the proposed changes to the disc parking in Mount Durand published in La Gazette Officielle on 26th August, 1992, except that the half-hour disc parking place will be on the south side of the road between the two vehicular entrances of the house named "Les Vignes".

(b) To create an un/loading bay in Park Street outside the entrance to Holy Trinity Church Hall. The wording of the legislation remains unchanged.

(c) To introduce 4 ten-hour disc parking spaces in Charroterie to compensate for the loss of the 2 five-hour spaces in Park Street.

(d) To introduce 3 two-hour disc parking spaces in Doyle Street.

(e) To change the 18 parking spaces at La Valette, between the rock outcrop and the entrance to the Mixed Bathing Pools, from two-hour to ten-hour on 1st October each year instead of 1st November.
