

THE STATES POST OFFICE BOARD, in pursuance of the powers conferred upon it by sections 13, 14, 15, 16, 18, 20, 23, 28 and 68 of the Post Office (Guernsey) Law, 1969, as amended (a), hereby orders:-

Amendments to  
Inland Post  
Order of 1983.

1. The First, Second, Fourth, Fifth and Sixth Schedules of the Post Office (Inland Post) Order, 1983, as amended (b), are repealed and the Schedules set out in the First, Second, Third, Fourth and Fifth Schedules to this Order are substituted therefor.

Citation.

2. This Order may be cited as the Post Office (Inland Post) (Amendment) Order, 1990.

Commencement.

3. This Order shall come into force on the 17th day of September, 1990.

## PART II

## Conditions which must be complied with

1. A packet for transmission by registered post shall:-
  - (a) be handed for registration to an officer of the States Post Office on duty at a post office; or
  - (b) be handed for registration to some officer of the States Post Office authorised to receive packets for registration though not on duty at a post office,

and any registered postal packet which has been transmitted to its original address, and which is redirected in pursuance of section twenty-two of this Order, shall also be handed to such an officer as aforesaid.

2. (1) Subject to the provisions of this Order, the fee chargeable for the registration of the packet, and any other sum chargeable thereon, shall be prepaid.

(2) On the posting of the packet the person handing over the packet shall obtain a certificate bearing thereon an acknowledgement that the registration fee has been paid.
