**The Social Insurance (Contributions)(Amendment) Regulations, 1994**

**THE GUERNSEY SOCIAL SECURITY AUTHORITY**, in exercise of the powers conferred upon it by sections 11, 20 and 116 of the Social Insurance (Guernsey) Law, 1978, as amended(a), hereby orders:-

**Amendments**

1. In paragraph (1) of Regulation 41 of the Social Insurance (Contributions) (Guernsey) Regulations, 1978, as amended(b) (hereinafter referred to as the "principal Regulations"), the word "twice" is inserted immediately before the words "the current lower weekly earnings limit and fifty-two".

2. The Seventh Schedule to the principal Regulations is substituted by the Schedule set out in the Schedule to these Regulations.

**Repeals**

3. The Social Insurance (Contributions) (Amendment) Regulations, 1993(c) are repealed.

**Extent**

4. These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

**Citation**

5. These Regulations may be cited as the Social Insurance (Contributions) (Amendment) Regulations, 1994.



**EXPLANATORY NOTE**

(This note is not part of the Regulations but is intended to explain their general purport.)

These Regulations double the limit of annual income below which a person may be excepted from liability to pay Class 3 (non-employed) contributions and specify the lower weekly and monthly earnings limits for the contribution year commencing 1 January 1995.
