The Post Office (Inland Post) (Amendment) (No.3) Order, 1979

THE STATES POST OFFICE BOARD, in pursuance of the powers conferred upon it by sections thirteen, fourteen, fifteen, sixteen, eighteen, twenty, twenty-eight and sixty-eight of the Post Office (Guernsey) Law, 1969, as amended(a), hereby orders:-

Amendments to
Inland Post
Order of 1973.

1. The Post Office (Inland Post) Order, 1973, as amended(b), is hereby further amended as follows:-

- (a) in paragraph (b) of subsection (3) of section twenty-three thereof the words "nine new pence" are hereby repealed and the words "ten new pence" are hereby substituted therefor;
- (b) in subsection (3) of section thirty-one thereof the words "nine new pence" are hereby repealed and the words "ten new pence" are hereby substituted therefor;
- (c) in subsections (2) and (3) of section thirty-eight thereof the words "nine new pence" are hereby repealed and the words "ten new pence" are hereby substituted therefor;
- (d) in section forty-one thereof the words "two pounds" are hereby repealed and the words "fifteen pounds" are hereby substituted therefor;

- (e) in sub-paragraph (a) of paragraph 4 of the First Schedule thereto the figures and letters "66p", "86p", "£1.06", "£1.16", "£1.26", "£1.36", "£1.46", "£1.51", "£1.56" and "£1.61", are hereby repealed and the figures and letters "76p", "99p", "£1.20", "£1.31", "£1.42", "£1.53", "£1.64", "£1.70", "£1.76" and "£1.82" are hereby respectively substituted therefor;
- (f) paragraphs 5 and 7 of the Second Schedule thereto are hereby repealed;
- (g) in Column two of paragraph 2 of the Fourth Schedule thereto the figure and letter "60p" are hereby repealed and the figure and letter "80p" are hereby substituted therefor;
- (h) Part I of the Fifth Schedule thereto is repealed and the Part set out in the First Schedule to this Order is substituted therefor;
- (i) Part I of the Sixth Schedule thereto is repealed and the Part set out in the Second Schedule to this Order is substituted therefor.

2. Paragraphs (l) and (m) of section three of The Post Office (Miscellaneous Amendments) (No.2) Order, 1975 (c), and paragraphs (c), (d), (e), (h), (j) and (1) of section three of and the Tenth Schedule to The Post Office (Miscellaneous Amendments) Order, 1977 (d), are hereby repealed.
