THE BAILIFF OF GUERNSEY, in exercise of the powers conferred on him by subsection (2) of section eighteen of the Court of Appeal (Guernsey) Law, 1961(a), hereby orders:-

1. The Court of Appeal (Civil Division) (Costs and Fees) (Guernsey) Rules, 1964(b) (hereinafter referred to as "the principal Rules"), are hereby amended as follows:-

(a) in Rule 5 thereof:-

(i) in paragraph (1) thereof the words "two shillings" are repealed and the words "forty new pence" are substituted therefor;

(ii) in paragraph (2) thereof the words "two pence" are repealed and the words "twenty new pence" are substituted therefor;

(b) the Schedule thereto is repealed and the Schedule set out in the Schedule to these Rules is substituted therefor.

Saving.

2. Notwithstanding anything contained in these Rules, the provisions of the principal Rules shall continue to have effect in relation to any proceeding or matter commenced before the coming into force of these Rules in all respects as if these Rules had not been made.
