THE IMMIGRATION (GUERNSEY) (AMENDMENT) RULES 1989

Made 11 August 1989
Laid before the States
Coming into operation 12 August 1989

THE STATES BOARD OF ADMINISTRATION in exercise of the powers conferred upon it by sub-section (2) of Section Three of the Immigration Act 1971, as extended to the Bailiwick by the Immigration (Guernsey) Order 1972, as varied by the Immigration (Guernsey) (Variation) Order 1982, and the Criminal Justice Act 1982 (Guernsey) Order 1983, hereby makes the following Rules:-

1. AMENDMENT TO RULES OF 1983.

The Immigration (Guernsey) Rules 1983(a) as amended (b), (c), (d), (e) and (f) are hereby further amended by substituting the following Appendix for the Appendix of the said Rules:-

APPENDIX

NATIONALS OF FOREIGN COUNTRIES WHO NEED VISAS FOR THE BAILIWICK OF GUERNSEY

EUROPE

Nationals of Turkey other than:

- (a) those who qualify for admission to the Bailiwick as returning residents in accordance with paragraph 57; and
- (b) those who seek leave to enter the Bailiwick within the period of an earlier leave in circumstances where, by virtue of section 3(3)(b) of the Act, any limitation on or condition of that earlier leave applies to the subsequent leave.

Nationals of Albania, Bulgaria, Czechoslovakia, German Democratic Republic, Hungary, Poland, Romania, USSR.

ASIA

Nationals of Pakistan other than:

- (a) those who qualify for admission to the Bailiwick as returning residents in accordance with paragraph 57; and
- (b) those who seek leave to enter the Bailiwick within the period of an earlier leave in circumstances where, by virtue of section 3(3)(b) of the Act, any limitation on or condition of that earlier leave applies to the subsequent leave.

Nationals of all other countries except Bahrain, Israel, Japan, Kuwait, Republic of Korea, Qatar and United Arab Emirates.

AFRICA

Nationals of all countries except Algeria, Ivory Coast, Morocco, Niger, Tunisia and the Republic of South Africa.

AMERICA

Nationals of Cuba, Haiti and the Argentine Republic.

CITIZENS OF COMMONWEALTH COUNTRIES WHO NEED VISAS FOR THE BAILLIWICK OF GUERNSEY

Citizens of Bangladesh, Ghana, India, Nigeria and Sri Lanka other than those described in paragraphs (a) and (b) above in the item relating to Pakistan."

2. REPEALS

Paragraph 35 of section one of the Immigration (Guernsey)(Amendment) Rules 1986, the Immigration (Guernsey)(Amendment No 3) Rules 1986 and the Immigration (Guernsey)(Amendment) Rules 1987, are repealed.


3. CITATION

These Rules may be cited as the Immigration (Guernsey)(Amendment) Rules 1989.

These Rules shall come into force on the twelfth day of August 1989.

EXPLANATORY NOTE

The Rules amend the Immigration (Guernsey) Rules 1983 and require certain nationals of Turkey to obtain visas for journeys to the Bailiwick of Guernsey. Haiti has also been added to the list in the Appendix of those nationals requiring visas.
