The Parking Places (Amendment) Order, 1977

THE ISLAND POLICE COMMITTEE, in exercise of the powers conferred upon it by section one of the Road Traffic (Parking Places) Ordinance, 1963(a), hereby orders:-

1. The Parking Places Order, 1968, as amended(b), is hereby further amended as follows:-

- (a) subsection (2) of section eight thereof is repealed;
- (b) in paragraph (c) of section nine thereof -
  - (i) immediately after the letter and figures "D71" there are inserted the letter and figures "D72";
  - (ii) immediately after the letter and figures "D85" there are inserted the letter and figures "D88";
- (c) in paragraph (d) of section nine thereof -
  - (i) immediately after the letter and figures "D50" there are inserted the letters and figures "D52, D53";
  - (ii) the letters and figures "D72" and "D74" are respectively repealed;
- (d) in paragraph (e) of section nine thereof the word, letters and figures "D52, D53, D54, D103 and D104" are repealed and the word, letters and figures "D54, D103, D104, D106, D107 and D108" are substituted therefor;
- (e) in paragraph (g) of section nine thereof the letter and figures "D88" are repealed;
- (f) in the entry relating to disc parking place No. D10 in the third column of Part I of the First Schedule thereto the words "but excluding approved parking place No. A2" are repealed;
- (g) the entry relating to disc parking place No. D53 in the third column of Part I of the First Schedule thereto is repealed and the entry "The south side of the road between a parking sign placed as near as may be to its junction with Bridge Road and a parking sign placed as near as may be opposite to its junction with Hougue Jehannet Road, Vale." is substituted therefor;
- (h) the entries relating to disc parking place No. D62 in each of the columns of Part I of the First Schedule thereto are repealed and the entries in each of the columns of the First Schedule to this Order are substituted therefor;

- (i) the entries relating to disc parking place No. D74 in each of the columns of Part I of the First Schedule thereto are repealed;
- (j) immediately after the entries relating to disc parking place No. D105 in each of the columns of Part I of the First Schedule thereto there are inserted respectively the entries in each of the columns of the Second Schedule to this Order;
- (k) the entries relating to approved parking place No. A2 in each of the columns of Part II of the First Schedule thereto are repealed.

2. This Order may be cited as the Parking Places (Amendment) Order, 1977.

3. This Order shall come into force on the twenty seventh day of June , nineteen hundred and seventy-seven.

FIRST SCHEDULE

Section one (h)

"D62	The unnamed road to the north and east of the plantation at North Side, Vale.	The south and east sides of the road between a parking sign placed as near as may be to its junction with Bridge Road and a parking sign placed as near as may be to its junction with North Side."

SECOND SCHEDULE

Section one (j)

"D106	North side of harbour, Saint Sampson.	The south side of the road between a parking sign placed as near as may be opposite to its junction with Hougue Jehannet Road, Vale and a parking sign placed near to the entrance of the first pier to the east thereof.
D.107	Le Crocq, south side of harbour, Saint Sampson.	The west side of Le Crocq between a parking sign placed opposite the Harbour Master's Office and a parking sign placed as near as may be to the northern end of Le Crocq.
D108	Cordier Hill, Saint Peter Port.	The north side of the road between a parking sign placed as near as may be opposite its junction with the lane leading to Cordier Hill Steps and a parking sign placed as near as may be to the rear entrance to the Convent of Mercy."
