The Health Service (Pharmaceutical) (Payment of Approved Suppliers) (Amendment) (Guernsey) Regulations, 1986

Made 26 August, 1986

Laid before the States

Coming into Operation 1 September, 1986

THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by section 12 of the Health Service (Pharmaceutical) (Guernsey) Law, 1972, as amended^(a), hereby orders:-

Amendments to the Regulations of 1983

1. The Health Service (Pharmaceutical) (Payment of Approved Suppliers) (Guernsey) Regulations, 1983, as amended^(b), are hereby further amended as follows:-

(a) in Regulation 1(1) thereof, the definitions of the expressions "specified amount" and "specified percentage" are repealed and the following definitions are substituted therefor -

"specified percentage" means, in relation to any provision of these Regulations specified in Part I of the First Schedule thereto and in respect of the class of approved supplier referred to in the first column of the said Part I of the Schedule, such amount as is shown in relation to that class of approved supplier in the second column of the said Part I of the Schedule;

"specified amount" means, in relation to any provision of these Regulations specified in Part II of the First Schedule thereto and in respect of the class of approved supplier referred to in the first column of the said Part II of the Schedule, such amount as is shown in relation to that class of approved supplier in the second column of the said Part II of the Schedule;"

- (b) paragraphs (1) and (2) of Regulation 2 thereof are repealed and the following paragraphs are substituted therefor -

"(1) Subject to the provisions of the next following paragraph, an approved supplier of any class shall be paid out of the Fund in respect of each item of pharmaceutical benefit supplied by him under the Law, on or after the 1st day of September, 1986, the sum of the following amounts, that is to say:-

- (a) an amount equal to the amount of the basic price of the ingredients;
- (b) the specified percentage of that amount in respect of that class of approved supplier;
- (c) the specified amount for the container in respect of that class of approved supplier;
- (d) a dispensing fee in accordance with Part I of the Second Schedule to these Regulations in respect of that class of approved supplier;
- (e) an additional dispensing fee in accordance with Part II of the Second Schedule to these Regulations in respect of that class of approved supplier;

(2) The amount payable to an approved supplier of any class under paragraph (1) of this Regulation in respect of any item of pharmaceutical benefit shall be reduced -

- (a) by the percentage amount set out in the second column of the Fifth Schedule thereto opposite the amounts within the scale corresponding to the amount of the basic price of the ingredients supplied set out in the first column of that Fifth Schedule;
- (b) by an amount equal to the amount of any prescription charge received or recoverable by him in respect of that item.";

- (c) the First Schedule thereto is repealed and the Schedule set out in the First Schedule to these Regulations is substituted therefor;

- (d) the Second Schedule thereto is repealed and the Schedule set out in the Second Schedule to these Regulations is substituted therefor;
- (e) the Third Schedule thereto is repealed and the Schedule set out in the Third Schedule to these Regulations is substituted therefor;
- (f) immediately after the Fourth Schedule thereto there is inserted the additional Schedule entitled "FIFTH SCHEDULE" set out in the Fourth Schedule to these Regulations.

Repeal

2. The Health Service (Pharmaceutical) (Payment of Approved Suppliers) (Amendment) (Guernsey) Regulations, 1984^(c), is hereby repealed.

Extent

3. These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

Citation

4. These Regulations may be cited as the Health Service (Pharmaceutical) (Payment of Approved Suppliers) (Amendment) (Guernsey) Regulations, 1986.

Collective Title

5. These Regulations and the Health Service (Pharmaceutical) (Guernsey) Regulations, 1983 may be cited together as the Health Service (Pharmaceutical) (Payment of Approved Suppliers) (Guernsey) Regulations, 1983 and 1986.

Commencement

6. These Regulations shall come into operation on the 1st day of September, 1986.
