The Post Office (Miscellaneous Amendments) Order, 1979

Made 16th July 1979
Laid before the States
Coming into Operation 20th August 1979

THE STATES POST OFFICE BOARD, in pursuance of the powers conferred upon it by sections thirteen, fourteen, fifteen, sixteen, eighteen, nineteen, twenty, twenty-eight and sixty-eight of the Post Office (Guernsey) Law, 1969, as amended (a), hereby orders:-

1. The Post Office (Overseas Letter Post) Order, 1973, as amended (b), is hereby further amended as follows:-

(a) in Part III of the Arrangement of Sections thereof the new entry "32. Compensation for unregistered packets" is hereby inserted therefor;

(b) subsection (1) of section six is hereby repealed and the following subsection is hereby substituted therefor:-

"6. (1) There shall be charged and paid:-

(a) on every air letter of the smaller size, a rate of postage of twelve new pence;

(b) on every air letter of the larger size, a rate of postage of 12.5p;

(c) on every Forces air letter, a rate of postage of seven new pence;

(d) on other air mail packets, the rates of postage specified in the Third Schedule to this Order."

(c) in subsection (3) of section twelve thereof the words "forty new pence" are hereby repealed and the words "forty-five new pence" are hereby substituted therefor;

- (d) in section twenty-four thereof the words "sixty new pence" are hereby repealed and the words "eighty new pence" are hereby substituted therefor;
- (e) in paragraph (c) of subsection (2) of section twenty-seven thereof the words "sixty new pence" are hereby repealed and the words "sixty-five new pence" are hereby substituted therefor;
- (f) in paragraphs (a) and (b) of section twenty-eight thereof the words "nine pounds" are hereby repealed and the words "ten pounds" are hereby substituted therefor;
- (g) in paragraph (d) of subsection (1) of section thirty thereof the words "six hundred pounds" are hereby repealed and the words "seven hundred and fifty pounds" are hereby substituted therefor;
- (h) in paragraph (b) of the proviso to subsection (1) of section thirty-one thereof the words "six hundred pounds" are hereby repealed and the words "seven hundred and fifty pounds" are hereby substituted therefor;
- (i) immediately after section thirty-one of Part III thereof the following new section is hereby inserted therefor:-

"Compensation for unregistered packets

32. Subject to the provisions of this Order:-

- (a) if an article of value enclosed in or forming part of an unregistered postal packet is lost or damaged so as entirely to destroy its value whilst in the custody of the Board, the Board may pay to any person or foreign administration who may in the opinion of the Board establish a reasonable claim to compensation (having regard to the nature of the article, the care with which it was packed, and other circumstances) such sum not exceeding ten pounds as it may think just;
- (b) if an unregistered postal packet is lost whilst in the post, the Board may pay to the sender or to any other person or foreign administration who may in the

opinion of the Board establish a reasonable claim to compensation a sum not exceeding ten pounds. Provided that compensation shall not be payable in respect of the same packet under both subsections of this section."

- (j) in section thirty-three thereof the words "or other registered postal packet", are hereby repealed and the words "registered postal packet or other unregistered postal packet" are hereby substituted therefor;
- (k) in subsection (1) of section thirty-four thereof the figures and letter "12.5p" are hereby repealed and the words "fifteen new pence" are hereby substituted therefor;
- (l) the First, Second, Third, Sixth and Seventh Schedules thereto are hereby repealed and the Schedules set out in the First, Second, Third, Fourth and Fifth Schedules to this Order are hereby respectively substituted therefor;

2. The Post Office (Overseas Parcel Post) Order, 1973, as amended (c) is hereby further amended as follows:-

- (a) in section five thereof the words "forty new pence" are hereby repealed and the words "forty-five new pence" are hereby substituted therefor;
- (b) in section fifteen thereof the words "sixty new pence" are hereby repealed and the words "eighty new pence" are hereby substituted therefor;
- (c) paragraph (b) of subsection (1) of section sixteen thereof is hereby repealed and the following paragraph is hereby substituted therefor -

"(b) the sender shall also pay to the Board at the time that any amount is paid in accordance with the undertaking referred to in paragraph (a) of this subsection or repaid by the Board in accordance with paragraph (e) of this subsection a fee of thirty new pence for each parcel posted;"

- (d) in paragraph (e) of subsection (1) of section seventeen thereof the words "six hundred pounds" are hereby repealed and the words "seven hundred and fifty pounds" are hereby substituted therefor;
- (e) in paragraph (c) of the proviso to subsection (1) of section eighteen thereof the words "six hundred pounds" are hereby repealed and the words "seven hundred and fifty pounds" are hereby substituted therefor;
- (f) in subsection (1) of section twenty thereof the figures and letter "12.5p" are hereby repealed and the words "fifteen new pence" are hereby substituted therefor;
- (g) paragraphs (a) and (b) of subsection (5) of section twenty-one are hereby repealed and the following paragraphs are hereby substituted therefor;
 - (a) where a parcel or parcels are stored for a period not exceeding twenty-eight days, the fee shall be one pound and fifty new pence for each parcel, except where two or more parcels are posted simultaneously by a sender to the same addressee, when the fee shall be:-
 - (i) where there are not more than five parcels, one pound and twenty new pence for each parcel;
 - (ii) where there are more than five parcels but not more than thirty, one pound and twenty new pence for each of the first five parcels and then seventy new pence for each additional parcel;
 - (iii) where there are more than thirty parcels, for the first thirty parcels the fee for each as prescribed in sub-paragraph (ii) of paragraph (a) of this subsection and then forty-five new pence for each additional parcel;"
 - (b) where a parcel is stored for a period of more than twenty-eight days, the fee for each parcel shall be as in paragraph (a) of this subsection with an additional sum for each parcel calculated at the rate of ten new pence for each working day (or residual part of such day) of storage

after the first twenty-eight days.

- (h) the First, Second and Third Schedules thereto are repealed and the Sixth, Seventh and Eighth Schedules to this Order are respectively substituted therefor;

The Post Office (Miscellaneous Amendments) Order, 1975 (g).

Citation.

4. This Order may be cited as The Post Office (Miscellaneous Amendments) Order, 1979.

5. This Order shall come into force on the twentieth day of August nineteen hundred and seventy-nine.
