The Social Insurance (Increase of Benefit)(Guernsey) Regulations, 1980

Made 30th September, 1980
Laid before the States
Coming into operation 17th November, 1980.

THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by section twenty-seven, section thirty-nine, section fifty and section sixty-nine of the Social Insurance (Guernsey) Law, 1978, and by Part II of the Fourth Schedule to that Law, and in exercise of all other powers enabling it in that behalf, hereby orders:-

Interpretation

1. (1) In these regulations, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them, that is to say:-

"the Law" means the Social Insurance (Guernsey) Law, 1978;

"the relevant day" means the seventeenth day of November, nineteen hundred and eighty;

and any other expressions have the same meanings as in the Law.

(2) Except where the context otherwise requires, any reference in these regulations to any enactment or regulations shall be construed as including a reference to that enactment or those regulations, as the case may be, as amended, repealed or revoked and replaced by or under any other enactment or by any other regulations.

(3) The Interpretation (Guernsey) Law, 1948, shall apply to the interpretation of these regulations as it applies to the interpretation of a Guernsey enactment.

Higher rates of widow's benefit and old age pension payable at reduced rates owing to partial satisfaction of contribution conditions

2. The Schedule to the Social Insurance (Widow's Benefit and Old Age Pensions) (Guernsey) Regulations, 1978, is hereby repealed and the Schedule set out in the First Schedule to these regulations is hereby substituted therefor.

Higher rates of unemployment benefit, sickness benefit and invalidity benefit payable at reduced rates owing to partial satisfaction of contribution conditions

3. (1) The Second Schedule to the Social Insurance (Unemployment, Sickness and Invalidity Benefit) (Guernsey) Regulations, 1978, is hereby repealed and the Schedule set out in the Second Schedule to these regulations is hereby substituted therefor.

(2) The Third Schedule to the Social Insurance (Unemployment, Sickness and Invalidity Benefit) (Guernsey) Regulations, 1978, is hereby repealed and the Schedule set out in the Third Schedule to these regulations is hereby substituted therefor.

Higher rates of maternity allowance payable at reduced rates owing to partial satisfaction of contribution conditions

4. The First Schedule to the Social Insurance (Benefits) (Miscellaneous Provisions) (Guernsey) Regulations, 1978, is hereby repealed and the Schedule set out in the Fourth Schedule to these regulations is hereby substituted therefor.

Transitional provisions regarding the payment of the increased amount of maternity grant

5. Where a woman has become entitled to a maternity grant (whether payment has been made or not) before the relevant day and her confinement occurs on or after that day, or, as the case may be, her pregnancy is otherwise terminated on or after that day, she shall be entitled to a maternity grant at the rate specified in Part III of the Schedule to the Social Insurance (Rates of Contributions and Benefits, etc.) (Guernsey) Ordinance, 1980.

Higher amounts of death grant payable at reduced amounts owing to partial satisfaction of contribution conditions

6. The Second Schedule to the Social Insurance (Benefits) (Miscellaneous Provisions) (Guernsey) Regulations, 1978, is hereby repealed and the Schedule set out in the Fifth Schedule to these regulations is hereby substituted therefor.

Higher rates of increase of industrial disablement benefit under section fifty of the Law where constant attendance is required

7. The Second Schedule to the Social Insurance (Industrial Injuries Benefits) (Guernsey) Regulations, 1978, is hereby repealed and the Schedule set out in the Sixth Schedule to these regulations is hereby substituted therefor.

Amendments to Social Insurance (Benefits)(Transitional Provisions)(Guernsey) Regulations, 1978

8. (1) The Social Insurance (Benefits)(Transitional Provisions) (Guernsey) Regulations, 1978, as amended, are hereby further amended as follows, that is to say:-

- (a) in sub-paragraph (a) of paragraph (2) of regulation nineteen thereof, for the words "seven pounds and thirty pence" there are hereby substituted the words "eight pounds and eighty pence";
- (b) in sub-paragraph (b) of the said paragraph (2), for the words "eleven pounds and thirty pence" there are hereby substituted the words "thirteen pounds and fifty-five pence";
- (c) in sub-paragraph (b) of paragraph (2) of regulation thirty-five thereof, for the words "fifty pence" there are hereby substituted the words "sixty pence";
- (d) in sub-paragraph (b) of paragraph (1) and sub-paragraph (b) of paragraph (2) of regulation thirty-six thereof, for the words "twenty-five pence" there are hereby substituted the words "thirty pence".

(2) For the purposes of paragraph (2) of the said regulation thirty-five and paragraph (2) of the said regulation thirty-six, any reckonable contributions paid in respect of contribution weeks before the eighteenth day of November, nineteen hundred and eighty and which do not on that day make up nine (or a multiple of nine) contributions, shall be treated as if they had been paid in respect of contribution weeks commencing on or after that date.

Amendments to Social Insurance (Benefits)(Miscellaneous Provisions) (Guernsey) Regulations, 1978

9. The Social Insurance (Benefits)(Miscellaneous Provisions)(Guernsey) Regulations, 1978, as amended, are hereby amended as follows, that is to say, in paragraph (2) of regulation twenty-eight and regulation twenty-nine thereof, for the words "three pounds" there are hereby substituted the words "three pounds and fifty pence."

Amendment to Social Insurance (Unemployment, Sickness and Invalidity Benefit) (Guernsey) Regulations, 1978

10. Paragraph (f) of paragraph (1) of regulation six of the Social Insurance (Unemployment, Sickness and Invalidity Benefit)(Guernsey) Regulations, 1978, shall have effect, on or after the first day of January nineteen hundred and eighty-one, as if for the words "eleven pounds" therein there were substituted the words "thirteen pounds".

Repeal

11. Regulations 2, 3, 4, 5, 6, 7, sub-paragraph (b) of regulation 8 and regulation 9 of the Social Insurance (Increase of Benefit)(Guernsey) Regulations, 1979 are hereby repealed together with the First, Second, Third, Fourth, Fifth and Sixth Schedules thereto.

Citation

12. These regulations may be cited as the Social Insurance (Increase of Benefit)(Guernsey) Regulations, 1980.

Commencement

13. These regulations shall come into force on the seventeenth day of November, nineteen hundred and eighty.

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport.)

These regulations increase the reduced rates of widow's benefits, old age pension, unemployment benefit, sickness benefit, invalidity benefit and maternity allowance payable under the Social Insurance (Guernsey) Law, 1978, in order to bring them into correspondence with the higher standard rates of such benefits approved by the States on the 31st July, 1980 (regulations two, three and four); increase the reduced amounts of death grant payable under that Law in order to bring them into correspondence with the higher standard amount of death grant approved by the States as aforesaid (regulation six); and revise the rates of increase of industrial disablement benefit where constant attendance is required (regulation seven). The remaining provisions of these regulations effect minor consequential and other amendments.
