

## GUERNSEY STATUTORY INSTRUMENT

The Parking Places (Amendment) (No. 2) Order, 2003

Made ..... 5 August 2003

Coming into operation on.....11<sup>th</sup> August 2003

**THE STATES TRAFFIC COMMITTEE**, in exercise of the powers conferred upon it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended(a), hereby orders:-

1. The Parking Places Order, 1991, as amended(b) is further amended in accordance with Articles 2 to 6 of this Order.
2. In Part A of Schedule 1, the entry relating to Disc Parking Place No. DA9a is deleted.
3. In Part E of Schedule 1, for the entry relating to Disc Parking Place No. DE11 substitute the following entry –

“DE11	Mount Durand	The south side of the road within the limits indicated by parking signs.”

4. In Part A of Schedule 2, in the third column of the entry relating to Approved Parking Place No. AA42 insert “But excluding between 8.30am and 5pm the portion of the north side of the road within the limits indicated by signs as being reserved for permit holders only”.
5. In Part C of Schedule 2, immediately following the entry relating to Approved Parking Place No. AC21 insert the following entries -

“AC22	Les Genats, Castel	The portion of road as near as may be to No.146, within the limits indicated as being reserved for persons in possession of a disabled person’s badge.
AC23	North Quay, Vale	The portion of the north side of the road between Trafalgar Road and La Hure Mare Road, within the limits indicated as being reserved for persons in possession of a disabled person’s badge.”
