THE STATES POST OFFICE BOARD, in pursuance of the powers conferred upon it by sections 13, 14, 15, 16, 28 and 68 of the Post Office (Guernsey) Law, 1969, as amended (a), hereby orders:-

Amendments to Inland Post Order of 1983. 1. The Post Office (Inland Post) Order, 1983, as amended (b) is further amended as follows:-


(a) Section 5 of the First Schedule thereto is repealed and the section set out in the First Schedule to this Order is substituted therefor.

(b) Section 4 of the Seventh Schedule thereto is repealed and the section set out in the Second Schedule to this Order is substituted therefor.

Citation. 2. This Order may be cited as the Post Office (Inland Post) (Amendment) (No. 2) Order, 1984.

Commencement. 3. This Order shall come into force on the 13th of December, 1984.

In respect of the Post Office (Overseas Parcel Post) Order, 1983, (b), the attached Amendment Order (No. 2) 1984, increases all air parcel postage rates to all countries with the exceptions of:
