**THE STATES TRAFFIC COMMITTEE**, in exercise of the powers conferred upon it by sections 2A(b) and 2B of the Motor Taxation and Licensing (Guernsey) Law, 1987, as amended <sup>(1)</sup>, hereby orders:-

**Amendments to 1995 Ordinance**

1. The Driving Licences (Guernsey) Ordinance, 1995, as amended <sup>(2)</sup>, is further amended as follows:-

(a) for Schedule 2 substitute the following Schedule -

*Driving test fees*

The fee payable prior to taking a test of competence relating to a motor vehicle of a class included in the category set out in column (1) of the Table below shall be the corresponding sum set out in column (2) thereof.

**The Driving Tests and Driving Licences (Increase of Fees) Regulations, 2003**

**Explanatory Note**

These Regulations set the fees that are chargeable for tests of competence to drive and driving licences with effect from 1st October, 2003, by increasing approximately by RPI the current fees that are set out in Schedule 2 and Schedule 3 respectively of the Driving Licences (Guernsey) Ordinance, 1995, as amended.
