GUERNSEY STATUTORY INSTRUMENT

1997 No. 25 (No. 2)

The Parking Places (Amendment) Order, 1997

Made on the 1st September 1997
Coming into force on the 3rd September 1997

THE STATES TRAFFIC COMMITTEE, in exercise of the powers conferred upon it by Section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended(a), hereby orders:-

1. The Parking Places Order, 1991, as amended(b), is further amended in accordance with Articles 2 to 6 inclusive of this Order.

2. In Part C of Schedule 1, immediately after the entry relating to disc parking place No. DC4, insert the following entry-

| No. | Situation | 2 hour disc Parking Places |
|-------|-----------------|---|
| "DC4a | South Esplanade | The northern portion of the west side of the road within the limits indicated by signs, but excluding Approved Parking Place No. AB4a." |

3. In Part E of Schedule 1 -

- (a) in the third column of the entry relating to disc parking place No. DE5, for "The west side of the road between the junctions with Castle Pier and La Vallette" substitute "The southern portion of the west side of the road, within the limits indicated by signs"
- (b) in the third column of the entry relating to disc parking place No. DE25, immediately after "signs" insert ", but excluding Approved Parking Places Nos. AB17a and AB17b".

4. In Part A of Schedule 2 -

- (a) in the third column of the entry relating to approved parking place No. AA43, for "and AC5c" substitute ", AC5c and AC5f";
- (b) in the third column of the entry relating to approved parking place No. AA51, insert "But excluding Approved Parking Place No. AC6a".

5. In Part B of Schedule 2, immediately after the entry relating to approved parking place No. AB17a, insert the following entry-

| No. | Situation | 23 hour approved parking places for motor bicycles |
|--------|----------------|--|
| "AB17b | New Paris Road | The north/east side of the portion of the road indicated by signs opposite the entrance to Oldwood Court." |

6. In Part C of Schedule 2 -

(a) immediately after the entry relating to approved parking place No. AC5e, insert the following entry-

| No. | Situation | Approved parking places |
|-------|-----------------|--|
| "AC5f | Clairval Estate | The portion of the road as near as may be to No. 31, indicated by signs as being reserved for persons in possession of a disabled person's badge." |

(b) immediately after the entry relating to approved parking place No. AC6, insert the following entry-

| No. | Situation | Approved parking places |
|-------|--------------------|---|
| "AC6a | Grand Bouet Estate | The portion of the main access road as near as may be to No. 8 Courtil Ash, indicated by signs as being reserved for persons in possession of a disabled person's badge." |

7. This Order may be cited as The Parking Places (Amendment) (No. 2) Order, 1997.

8. This Order shall come into force on the 3rd September 1997
