The Parking Places (Amendment) Order, 1983

Made the 22nd day of August, 1983

Coming into force on the 30th day of August, 1983.

THE ISLAND POLICE COMMITTEE, in exercise of the powers conferred upon it by section one of the Road Traffic (Parking Places) Ordinance, 1963, as amended (a) hereby orders:-

1. The Parking Places Order, 1968, as amended (b), is hereby further amended as follows:-

(a) in section six thereof -

(i) paragraph (iii) of proviso (a) is repealed and the following paragraph is substituted therefor -

"(iii) in any of the disc parking places specified in Part I of the First Schedule to this Order in accordance with the provisions of section nine of this Order regulating the parking of vehicles in any such disc parking place, notwithstanding that the vehicle is not on hire to a passenger;"

(ii) proviso (b) is repealed and the following proviso is substituted therefor -

"(b) in the case of a public vehicle in respect of which there is in force a private hire motor car licence, such person may park that vehicle in any of the disc parking places specified in Part I of the First Schedule to this Order in accordance with the provisions of section nine of this Order regulating the parking of vehicles in any such disc parking place, notwithstanding that the vehicle is not on hire to a passenger.";

(b) in paragraph (a) of section nine thereof the words, letters and figures "Nos. D21 and D115" are repealed and the word, letter and figures "No. D21" are substituted therefor;

(c) in paragraph (d) of section nine thereof -

(i) the letter and figures "D78" are repealed;

(ii) the word, letters and figures "D109 and D116" are

- (d) in paragraph (e) of section nine thereof the word, letters and figures "D108 and D121" are repealed and the word, letters and figures "D108, D121 and D124" are substituted therefor;
- (e) in paragraph (g) of section nine thereof -
 - (i) the letters and figures "D80" and "D81" are respectively repealed;
 - (ii) the word, letters and figures "D117 and D118" are repealed and the word, letters and figures "D118, D125, D126 and D127" are substituted therefor;
- (f) the entries relating to disc parking places Nos. D78, D80, D81, D115, D116 and D117 in each of the columns of Part I of the First Schedule thereto are repealed;
- (g) immediately after the entries relating to disc parking place No. D121 in each of the columns of Part I of the First Schedule thereto there are inserted respectively the entries in each of the columns of the First Schedule to this Order;
- (h) in Part II of the First Schedule thereto -
 - (i) the entries relating to approved parking place No. A67 in each of the columns thereof are repealed;
 - (ii) immediately after the entries relating to approved parking place No. 66 in each of the columns thereof there are inserted respectively the entries in each of the columns of the Second Schedule to this Order;
- (i) in Part III of the First Schedule thereto -
 - (i) the entries relating to approved parking place No. MB18 in each of the columns thereof are repealed;
 - (ii) immediately after the entries relating to approved parking place No. MB19 in each of the columns thereof there are inserted respectively the entries in each of the columns of the Third Schedule to this Order.

2. This Order may be cited as the Parking Places (Amendment) Order, 1983.

3. This Order shall come into force on the thirtieth day of August, nineteen hundred and eighty-three.

FIRST SCHEDULE

Section one (g)

- "D122 Smith Street,
 Saint Peter Port. The south-east side of the top end of the road opposite the War Memorial between a parking sign placed as near as may be opposite its junction with Forest Lane and a parking sign placed as near as may be to its junction with the western end of Le Marchant Street.
- D123 Coupée Lane,
 Saint Peter Port. The west side of the road between parking signs placed as near as may be to its junction with Cornet Street.
- D124 La Grande Rue,
 Saint Martin. The whole area of the public car park on the west side of the road at its junction with the Route des Camps but excluding approved parking place No. MB21.
- D125 Mount Durand,
 Saint Peter Port. The south side of the road between a parking sign placed as near as may be to the premises known as Granville House opposite No. 83 Mount Durand and a parking sign placed as near as may be to the premises known as No. 48 Mount Durand opposite No. 63 Mount Durand.
- D126 Pedvin Street,
 Saint Peter Port. The north side of the road between a parking sign placed as near as may be opposite No. 8 Pedvin Street and a parking sign placed as near as may be to its junction with Hauteville.
- D127 Saint George's
 Esplanade,
 Saint Peter Port. The landward side of the road between a sign placed as near as may be to the south of the premises known as the Piette Hotel and a parking sign placed as near as may be to the north of its junction with Paris Street. "

SECOND SCHEDULE

Section one (h) (ii)

- "A67 New Paris Road,
 Saint Peter Port. The east side of the road between a parking sign placed as near as may be to its junction with Piette Road and a parking sign placed as near as may be to its junction with Paris Street.
- A68 Richmond Avenue,
 Saint Peter Port. The east side of the road between a parking sign placed as near as may be to its junction with the Rue à L'Or and a parking sign placed as near as may be to the south-west corner of the Elizabeth College Playing Fields. "

THIRD SCHEDULE

Section one (i)

- "MB20 Victoria Road,
 Saint Peter Port. The portion of the west side of the road opposite its junction with La Couperderie indicated by parking signs as being reserved for motor bicycles.
