

The Post Office (Miscellaneous Amendments) Order, 1974

THE STATES POST OFFICE BOARD, in pursuance of the powers conferred upon it by sections thirteen, fourteen, fifteen, sixteen, eighteen, nineteen, twenty, twenty-three, twenty-eight and sixty-eight of the Post Office (Guernsey) Law, 1969, as amended, hereby orders:-

1. The Post Office (Overseas Letter Post) Order, 1973, as amended, is hereby further amended as follows:-

- (a) ~~in subsection (3) of section twelve thereof the words "twenty new pence" are hereby repealed and the words "twenty-seven new pence" are hereby substituted therefor;~~
- (b) ~~in section twenty-four thereof the words "twenty new pence" are hereby repealed and the words "forty new pence" are hereby substituted therefor;~~
- (c) ~~in paragraph (c) of subsection (2) of section twenty-seven thereof the words "twenty new pence" are hereby repealed and the words "twenty-five new pence" are hereby substituted therefor;~~
- (d) section thirty-four thereof is hereby repealed and the following section is hereby substituted therefor:-
- "34.(1)(a) The sender of an outgoing registered postal packet addressed to any country or place which is a party to the Universal Postal Union, on making a request in a form specified by the Board at the time of posting or within one year thereafter, and on payment of an advice of delivery fee of ten new pence if the request is made at the time of posting or twenty new pence if the request is made after posting, may obtain an advice of delivery of the packet.

(b) The advice of delivery form may, if the sender of the packet so requires, be transmitted by air to, or from, or both to and from the country or place of the address of the packet; and the sender shall, if the Board so directs, pay a further fee of one new penny for each transmission of the advice of delivery form by air.

(2) The sender of an outgoing registered postal packet addressed to any such country or place as aforesaid, on making a request within one year after the date of posting, and (unless an advice of delivery fee has already been paid in respect of the packet) on payment of an enquiry fee of twenty new pence, may cause an enquiry to be made into the suspected loss or non-delivery of the packet; in the event of such postal packet being lost and compensation being paid by the Board, such enquiry fee shall be refunded to the sender."

(e) ~~the~~ First, Second, Third, Sixth and Seventh Schedules thereto are hereby ~~repealed~~ and the Schedules set out in the First, Second, Third, Fourth and ~~Fifth~~ Schedules to this Order are hereby respectively substituted therefor.

2. The Post Office (Overseas Parcel Post) Order, 1973, as amended, is hereby further amended as follows:-

- (a) ~~in~~ section five thereof the words "twenty-five new pence" are hereby ~~repealed~~ and the words "twenty-seven new pence" are hereby substituted therefor;
- (b) ~~in~~ section fifteen thereof the words "twenty new pence" are hereby ~~repealed~~ and the words "forty new pence" are hereby substituted therefor;
- (c) section twenty thereof is hereby repealed and the following section is hereby substituted therefor:-

"20.(1)(a) The sender of an outgoing insured parcel, on making a request in a specified form at the time of posting or within one year thereafter, and on payment of an advice of delivery fee of ten new pence if the request is made at the time of posting or twenty new pence if the request is made after posting, may obtain an advice of delivery of the parcel.

(b) The advice of delivery form may, if the sender of the parcel so requires, be transmitted by air to, or from, or both to and from the country or place of address of the parcel; and the sender shall, if the Board so directs, pay a further fee of one new penny for each transmission of the advice of delivery form by air.

(2) The sender of an outgoing insured parcel, on making a request within one year after the day of posting, and (unless an advice of delivery fee has already been paid in respect of the parcel) on payment of an enquiry fee of twenty new pence, may cause an enquiry to be made into the suspected loss or non-delivery of the parcel; in the event of such parcel being lost and compensation being paid by the Board, such enquiry fee shall be refunded to the sender.";

(d) subsections (5) and (6) of section twenty-one thereof are hereby repealed and the following subsections are hereby substituted therefor:-

"(5) With respect to the clearance through customs of a parcel stored in bond, the Board may charge a fee as follows:-

(a) where a parcel is stored for a period not exceeding twenty-eight days, the fee shall be eighty new pence for each parcel, except where two or more parcels are posted simultaneously by a sender to the same addressee, when the fee shall be:-

- (i) where there are not more than five parcels, seventy-five new pence for each parcel;
  - (ii) where there are more than five parcels but not more than thirty, seventy-five new pence for each of the first five parcels and then fifty new pence for each additional parcel;
  - (iii) where there are more than thirty parcels, for the first thirty parcels the fee for each as prescribed in sub-paragraph (ii) of paragraph (a) of this subsection and then twenty-seven new pence for each additional parcel;
- (b) where a parcel is stored for a period of more than twenty-eight days, the fee for each parcel shall be as in paragraph (a) of this subsection with an additional sum for each parcel calculated at the rate of five new pence for each working day (or residual part of such day) of storage after the first twenty-eight days.
- (6) The fees charged under subsection (5) of this section with respect to each parcel (other than a parcel which is returned to its sender) shall be paid by the addressee if the parcel shall be delivered to him, or by the original addressee if the parcel shall be re-addressed in accordance with paragraph (c) or (d) of subsection (1) of this section.";
- (e) ~~the~~ First, Second and Third Schedules thereto are hereby repealed and the Schedules set out in the Sixth, Seventh and Eighth Schedules to this Order are hereby substituted therefor.
