THE STATES POST OFFICE BOARD, in pursuance of the powers conferred upon it by sections 13, 16, and 68 of the Post Office (Guernsey) Law, 1969, as amended (a), hereby orders:-

1. The Post Office (Overseas Letter Post) Order, 1983, (b), is hereby amended as follows:-

(a) in Section 23 thereof, for "£1.65" there is substituted "£1.75".

(b) in Section 25 (2) (c) thereof, for "£1.40" there is substituted "£1.55".

(c) in Sections 30 (a) and 30 (b) thereof for "£20" there is substituted "£22".

(d) in Section 32 (1) thereof for "25p" there is substituted "30p".

(e) The First, Second, Third and Sixth Schedules thereto are repealed and the Schedules set out in the First, Second, Third and Fourth Schedules to this Order are respectively substituted therefor.
