The Social Insurance (Contributions) (Amendment)

THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by section 20 of the Social Insurance (Guernsey) Law, 1978, as amended<sup>(a)</sup>, hereby orders:-

Amendment of the Seventh Schedule to the principal Regulations

1. The Seventh Schedule to the Social Insurance (Contributions) (Guernsey) Regulations, 1978, as amended<sup>(b)</sup>, is hereby repealed and the Schedule set out in the Schedule to these Regulations is hereby substituted therefor.

Repeals

2.(1) The Social Insurance (Contributions) (Amendment) (Guernsey) Regulations, 1985<sup>(c)</sup>, are hereby repealed.

(2) Regulation 4 of the Social Insurance (Contributions) (Amendment) (Guernsey) Regulations, 1986<sup>(d)</sup> is hereby repealed.

Extent

3. These Regulations shall have effect in the Islands of Guernsey, Alderney, Herm and Jethou.

4. These Regulations may be cited as the Social Insurance (Contributions) (Amendment) (No.2) (Guernsey) Regulations, 1986.


Collective title
