The Parking Places (Amendment) No.2 Order, 1996

Made on the ... .. 16th September, 1996  
Coming into force on the 22nd September, 1996

**THE STATES TRAFFIC COMMITTEE**, in exercise of the powers conferred upon it by Section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended (a), hereby orders:-

1. The Parking Places Order, 1991, as amended (b), is further amended in accordance with Articles 2 to 9 inclusive of this Order.

2. In Article 12.(a) delete AC2.

3. In Article 12 immediately after paragraph (a) insert the following paragraph-

"(b) in approved parking place AC2 or AC2a between 07.00 and 10.00 or between 17.00 and 19.00 Monday to Saturday except for the purpose of delivering to or collecting from trade premises for trade purposes."

4. In Part C of Schedule 1 in the third column of the entry relating to disc parking place DC23a immediately after "No. DH1" insert "and Approved Parking Place AB22b"

5. In Part D of Schedule 1 in the third column of the entry relating to disc parking place No. DD3, immediately after "George Road" insert "but excluding Approved Parking Place No. AB10a".

6. In Part E of Schedule 1, delete the entry relating to disc parking place No. DE16.

7. In Part A of Schedule 2 -

(a) immediately after the entry relating to approved parking place No. AA11, insert the following entry-

No	Situation	23 hour approved parking places
" AA11a	Gibauderie	The south east side of the portions of the road within the limits indicated by signs." ;

(b) for the entry relating to approved parking place No. AA13a substitute the following entry-

No	Situation	23 hour approved parking places
" AA13a	Doyle Road	The west side of the portion of the road near the Parish pump within the limits indicated by signs." ;

(c) in the third column of the entry relating to approved parking place No. AA14a, immediately after "No. AB18b" insert "or AC5e".

8. In Part B of Schedule 2 -

(a) immediately after the entry relating to approved parking place No. AB10 insert the following entry-

No	Situation	23 hour approved parking places for motor bicycles
" AB10a	Hauteville	The portion of the east side of the road immediately to the south of its junction with Havelet indicated by signs at the north end of Disc Parking Place No.DD3."

(b) immediately after the entry relating to approved parking place No. AB22a insert the following entry-

No	Situation	23 hour approved parking places for motor bicycles
" AB22b	South Quay, Saint Sampson	The portions of the south side of the road within the limits indicated by signs."

9. In Part C of Schedule 2 -

(a) immediately after the entry relating to approved parking place No. AC2 insert the following entry-

No	Situation	Approved parking places
" AC2a	South Esplanade	The portion of the north-east side of the road indicated by signs as being reserved for persons in possession of a disabled person's badge between 10.00 and 17.00 Monday to Saturday and 19.00 on any day and 07.00 on the next day following and all day on a Sunday or a Bank Holiday."


(b) immediately after the entry relating to approved parking place No. AC5d insert the following entry-

No	Situation	Approved parking places
" AC5e	St. Jacques	The portion of the north side of the road indicated by signs as being reserved for persons in possession of a disabled person's badge."

10. This Order may be cited as The Parking Places (Amendment) No. 2 Order, 1996.

11. This Order shall come into force on the 22nd September, 1996.
