The Social Insurance (Contributions) (Amendment)
(No. 3) (Guernsey) Regulations, 1979.

Made 18th September, 1979.
Laid before the States
Coming into operation 24th September, 1979.

THE STATES INSURANCE AUTHORITY, in exercise of the powers conferred upon it by section six and section twenty of the Social Insurance (Guernsey) Law, 1978, and in exercise of all other powers enabling it in that behalf, hereby orders:-

Amendment of regulation eleven of the principal regulations

1. In paragraph (5) of regulation eleven of the Social Insurance (Contributions) (Guernsey) Regulations, 1978, as amended (hereafter in these regulations referred to as "the principal regulations") for the full-stop at the end thereof there is hereby substituted a colon and immediately thereafter there is hereby inserted the following proviso:-

"Provided that where that person was not a self-employed person in respect of every week during the relevant contribution year, the Authority may direct that any repayment shall be made under this paragraph in such lesser amount than the amount which would otherwise have been repayable under this paragraph as the Authority shall consider to be just and equitable having regard to the extent of the period during which that person was a self-employed person in that year."

Amendment of regulation fifty-eight of the principal regulations.

2. Immediately after paragraph (1) of regulation fifty-eight of the principal regulations there is hereby inserted the following paragraph -

"(1A) The lower weekly earnings limit as respects the contribution year commencing on the first day of January, nineteen hundred and eighty, shall be twenty-two pounds and fifty pence, and the lower monthly earnings limit as respects that year shall be ninety-seven pounds and fifty pence."

Repeal

3. Paragraph (2) of regulation five of the Social Insurance (Contributions) (Amendment) (No. 2) (Guernsey) Regulations, 1979, is hereby repealed.

Citation and collective title


4. (1) These regulations may be cited as the Social Insurance (Contributions) (Amendment) (No. 3) (Guernsey) Regulations, 1979.

(2) These regulations, the Social Insurance (Contributions) (Guernsey) Regulations, 1978, the Social Insurance (Contributions) (Amendment) (Guernsey) Regulations, 1979, and the Social Insurance (Contributions) (Amendment) (No. 2) (Guernsey) Regulations, 1979, may be cited together as the Social Insurance (Contributions) (Guernsey) Regulations, 1978 to 1979.

Commencement

5. These regulations shall come into force on the twenty-fourth day of September , nineteen hundred and seventy-nine.

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport.)

These regulations further amend paragraph (5) of regulation eleven of the Social Insurance (Contributions) (Guernsey) Regulations, 1978, as amended, so as to empower the States Insurance Authority to regulate the amount repayable to a self-employed person whose contribution liability in respect of any contribution year has been re-assessed at a lower amount than that determined in the original assessment made in respect of that year in the case where that self-employed person was not a self-employed person throughout that year (regulation one); and specify the lower weekly and lower monthly earnings limits as respects the contribution year commencing on the first day of January, nineteen hundred and eighty.
