The Parking Places (Amendment) (No.2) Order, 1993

Made on the 6th October, 1993

Coming into force on the 10th October, 1993

THE STATES TRAFFIC COMMITTEE, in exercise of the powers conferred upon it by Section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended (a), hereby orders:-

1. The Parking Places Order, 1991, as amended (b), is amended further in accordance with Articles 2 to 12 inclusive of this Order.

2. In Article 9. immediately after paragraph (g)(ii) there is inserted:

- (h) in any disc parking place in Part G of Schedule 1 -
 - (i) between 06.00 and 10.00 except, for a continuous period not greater than 30 minutes, for the purpose of delivering to or collecting from trade premises for trade purposes; or
 - (ii) for a continuous period greater than 1 hour ending between 10.00 and 18.00.

3. In Article 12. -

(a) Paragraph (a), delete the letters, word and figures "AC2 or AC8" and replace with the following letters, word and figures "AC1, AC2, AC7 or AC8";

(b) Paragraph (b) delete "in approved parking place AC1 between 08.00 and 17.00, or", and delete "or AC7".

4. In the Parking Places (Amendment) Order, 1993 (c) (which repealed Article 12.(c)), delete the figure "9".

5. In Part B of Schedule 1 -

(a) immediately after the entry relating to disc parking place No. DB4d there is inserted the following additional entry:

No	Situation	Disc Parking Place
"DB4e	Back Street	The portion of the south-west side of the road within the limits indicated by parking signs."

(b) in the third column of the entry relating to disc parking place No. DB19 delete the word "east" and replace with the word "west", and insert at the end of the words ", but excluding Disc Parking Place No.DH2";

(c) in the third column of the entry relating to disc parking place No. DB20 insert at the end of the words ", but excluding Disc Parking Place No. DH1";

(d) the entry relating to disc parking place No. DB21 is repealed;

(e) in the third column of the entry relating to disc parking place No. DB22 delete the words "Commercial Road" and insert the following "Bridge Avenue, but excluding Disc Parking Places No. DH3 and DH4 and Approved Parking Place AC8".

(f) the entry relating to disc parking place No. DB23 is repealed;

(g) in the third column of the entry relating to disc parking place No. DB24 insert at the end of the words and figures ", and Disc Parking Place No. DH5";

(h) in the third column of the entry relating to disc parking place No. DB25 delete ", but excluding Approved Parking Place No. AC8".

(i) in the third column of the entry relating to disc parking place No. DB27 insert at the end of the words "within the limits indicated by parking signs".

6. In Part C of Schedule 1 -

(a) in the third column of the entry relating to disc parking place No. DC23 at the end of the words insert ", but excluding Approved Parking Places AB22 and AD8";

(b) in the third column of the entry relating to disc parking place No DC30 insert at the end of the words ", but excluding Approved Parking Place No. AB23".

7. In Part E of Schedule 1, immediately after the entry relating to disc parking place No. DE30 there is inserted the following additional entry:

No	Situation	Disc Parking Place
"DE30a	La Tonnelle and La Rue des Bas Courtils, Saint Sampson	The north and north-west sides of the road at the junction known as the Halfway within the limits indicated by parking signs, but excluding Approved Parking Place No. AB21a."

8. Immediately after Part G of Schedule 1 insert the following additional Part -

"Schedule 1 - (continued)

PART H

Disc Parking Places to which section 9(h) of this Order applies.

Vehicles

No	Situation	Unloading Bay alternating Disc Parking Place
DH1	South Quay, St Sampson	The portion of the south side of the road within the limits indicated by parking signs.

No	Situation	Unloading Bay alternating Disc Parking Place
DH2	New Road, St. Sampson	The portion of the west side of the road within the limits indicated by parking signs.
DH3	The Bridge, St. Sampson	The portion of the west side of the road to the south of its junction with Commercial Road between Approved Parking Place No. AC8 and Disc Parking Place No. DB22 within the limits indicated by parking signs.
DH4	The Bridge, St. Sampson	The portion of the west side of the road immediately to the south of the junction with Bridge Avenue within the limits indicated by parking signs.
DH5	The Bridge, Vale	The portion of the west side of the road between the north end of Disc Parking Place No. DB24 and Approved Parking Place No. AC9 within the limits indicated by parking signs."

9. In Part A of Schedule 2 -

(a) in the third column of the entry relating to approved parking place No. AA31 delete the words "and west";

(b) in the third column of the entry relating to approved parking place No. AA31a delete the word "portion" and replace with the word "portions".

(c) in the third column of the entry relating to approved parking place No. AA69 insert the words and figures "But excluding Approved Parking Place No. AC7."

10. In Part B of Schedule 2 -

a. immediately after the entry relating to approved parking place No. AB21 there is inserted the following additional entry:

No	Situation	23 hour Approved Parking Places for motor bicycles
"AB21a	La Tonnelle and La Rue des Bas Courtils, Saint Sampson	The portion of the north side of the road within the limits indicated by a parking sign." ;

b. in the third column of the entry relating to approved parking place No. AB23 delete the words "opposite the junction with Bridge End Road" and replace with the following words "within the limits indicated by signs";

11. In Part C of Schedule 2 -

(a) the entries relating to approved parking places No. AC7 and AC8 are repealed;

(b) immediately after the entry relating to approved parking place No. AC6 insert the following additional entries:

No	Situation	Approved Parking Place
"AC7	Les Genats, Castel	The portion of the road as near as may be to No. 136, indicated by signs as being reserved for persons in possession of a disabled person's badge.
AC8	The Bridge, St. Sampson	The portion of the road immediately to the south of the junction with Commercial Road, indicated by signs as being reserved for persons in possession of a disabled person's badge."

(c) in the third column of the entry relating to approved parking place No. AC9 delete the words "immediately adjacent to the junction with Bridge Avenue" and replace with the words "at the north end of the road".


12. In Part D of Schedule 2 delete the entry relating to approved parking place AD8 and replace with the following:

No	Situation	Disc Parking Place
"AD8	South Quay, St. Sampson	The portion of the north side of the road between Approved Parking Place No. AB22 and Disc Parking Place No. DC23 indicated by signs."

13. This Order may be cited as The Parking Places (Amendment) No.2 Order, 1993.

14. This Order shall come into force on the 10th October, 1993
