The Parking Places (No. 3) (Amendment) Order, 1999

Made ----- 10<sup>th</sup> August 1999

Coming into operation on ----- 16<sup>th</sup> August 1999

**THE STATES TRAFFIC COMMITTEE**, in exercise of the powers conferred upon it by section 1 of the Road Traffic (Parking Places) Ordinance, 1963, as amended(a), hereby orders:-

1. The Parking Places Order, 1991, as amended(b) is further amended in accordance with Articles 2 to 16 inclusive of this Order.
2. In Part B of Schedule 1, in the entry relating to disc parking place No. DB10, the words "Ann's Place and" are deleted from the second column, and the words "The north side of Ann's Place and" are deleted from the third column.
3. In part B of Schedule 1, in the third column of the entry relating to disc parking place No. DB22, the word "AB22e," is inserted immediately following the word "AB22c".
4. In part C of Schedule 1, in the third column of the entry relating to disc parking place No. DC23a, for "Place No. AB22b" there is substituted "Places Nos. AB22b and AC9a,"
5. In part A of Schedule 2, in the third column of the entry relating to approved parking place NoAA1, the words ", but excluding approved parking place No. AC1d." are inserted immediately following the word "signs".
6. In part A of Schedule 2, the entry relating to approved parking place No. AA34 is deleted.
7. In part A of Schedule 2, in the third column of the entry relating to approved parking place No. AA51, for "Place No. Ac6a" there is substituted "Places Nos. Ac6a and AC6c,"
8. In part A of Schedule 2, in the third column of the entry relating to approved parking place NoAA55, the words ", but excluding approved parking place No. AC1d." are inserted immediately following the word "estates".

9. In part A of Schedule 2, in the third column of the entry relating to approved parking place No. AA69, for "Place No AC7" there is substituted "Places Nos. AC7, AC7a, and AC7b".

10. In Part B of Schedule 2, immediately following the entry relating to approved parking place No. AB1, the following entry is inserted-

"AB1a	Ann's Place	The portion of the north side of the road, within the limits indicated by signs."

11. In Part B of Schedule 2, immediately following the entry relating to approved parking place No. AB22d, the following entry is inserted-

"AB22e	The Bridge, St Sampson	The portion of the west side of the road, immediately to the south of the pedestrian crossing, within the limits indicated by signs."

12. In Part C of Schedule 2, immediately after the entry relating to approved parking place No. AC1b, the following entries are inserted:

"AC1c	New Place	The portion of the south side of the road, as near as maybe to the west of Nos. 5 & 6, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge".

"AC1d	Le Hurel Housing Estate, St Martin	The portion of the north-eastern corner of the car park side of the road, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge".

13. In Part C of Schedule 2, immediately after the entry relating to approved parking place No. AC6b, the following entry is inserted:

"AC6c	Grand Bouet Estate	The portion of the main access road as near as maybe to the northern most footpath leading to Courtil Ash, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge".

14. In part C of Schedule 2, in the third column of the entry relating to approved parking place No. AC7a, the number "35" is substituted for the number "19".

15. In Part C of Schedule 2, immediately after the entry relating to approved parking place No. AC7a, the following entry is inserted:

"AC7b	Les Genâts, Castel	The portion of the road as near as maybe to No. 98, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge".

16. In Part C of Schedule 2, immediately after the entry relating to approved parking place No. AC9, the following entry is inserted:

"AC9a	South Quay, St Sampson	The portion of the south side of the road, immediately to the east of the pedestrian crossing, within the limits indicated by signs as being reserved for persons in possession of a disabled person's badge".

17. This Order may be cited as the Parking Places (Amendment) (No. 3) Order, 1999.

18. This Order shall come into force on the sixteenth day of August, 1999.
